To Whom It May Concern,

Thank you for submitting the plans for the Salon up-fit. The plans have been carefully reviewed by a qualified code enforcement official to examine for compliance with the North Carolina Fire Prevention Code and all other fire protection regulatory documents. There are some items that were found during the plan review process that need to be addressed before a final inspection of the new facility can be given. These items are outlined and described below.

Plan Review Notes

- 906.1 Fire Extinguishers
 - Minimum of (1) 2A10:BC fire extinguisher shall be installed per 75' distance of travel.
 - All Fire extinguisher shall be properly mounted and tagged by a fire extinguisher company.
- 506.1 Knox Box
 - The building owner has been required to install a Knox box.
 - \circ Provide entry key to be placed in the complex Knox box.

Notes:

- Fire Final Inspection required.
- Any additions or alterations to the fire alarm or sprinkler system will require separate submittal and permits.






SUBMITTAL INFORMATION

Permit Requirements

No building or structure or any part thereof shall be erected, extended, enlarged or structurally altered or moved until a zoning permit and any required trade permits have been issued by the Town of Lillington.

No new land usage may be initiated until a zoning permit and any other required permits have been issued by the Town of Lillington.

All Lillington Permit Applications are available at lillingtonnc.org/permits.

Fees

The Zoning Permit fee is \$50.00. Please be advised that additional permit applications and fees may be required depending on the scope of work associated with each project. A comprehensive list of fees can be found in the Lillington Fee Schedule for the current fiscal year.

Site Plan Requirements

All applications for permit shall include a plat or site plan drawn to scale which clearly shows:

- 1. The actual shape and dimensions of the lot to be built upon or used and total acreage in the lot.
- 15 W Front St. 2. The location of the proposed structure or use on the lot.
- 2500 sq. ft. 3. The exact location and size of existing structures and uses.
- The existing and intended use of each structure or portion of structure. 4.
- 5. The number of dwelling units the building is designed to accommodate, if applicable.
- The height and number of stories of the structure(s). 6.
- The location and design of any off-street parking and / or loading. Street parking /back
 The location and dimensions of driveways. For state-owned roads, an approved driveway permit from the lot North Carolina Department of Transportation (NCDOT) shall be required.
- 9. Date of plan preparation. 11/15/18
- 10. Location and description of landscaping, buffering and signs. Window planters, wooder 11. Such other information as may be necessary for determining whether the provisions of this ordinance are sign being met.

Building Trade Permits

The Town of Lillington issues all trade permits for work within the corporate limits or the extraterritorial jurisdiction (ETJ). Harnett County Inspections is contracted by the town for plan review and inspections. Construction plans for review are submitted *directly* to the Town of Lillington. Plans are subsequently transmitted to the county for review after zoning approval. Please contact Harnett County Central Permitting at 910-893-7525 or harnett.org/permits for any trade-related questions.

Fire Marshal Review

The Town of Lillington contracts with the Harnett County Fire Marshal's Office for projects requiring fire code approval. Fire code plan review applications are permitted separately and submitted directly to the county for review. Please contact Harnett County Central Permitting at 910-893-7525 or harnett.org/permits for further information.

Sign Permits

A Sign Permit Application is required for the erection or alteration of all signage in Lillington. Permit applications are available at lillington.org/permits. For further assistance, please contact the Town Planner at 910-893-0311.
