RE: Removal of 1-2,500-gallon Above Ground Tank, Liquid Transfer and Disposal of AST Lillington, NC

Mr. Davis:

CCI Environmental Services, Inc. (CCI) is pleased to submit this estimate for management and removal of the referenced storage tank and contents at the above referenced site per the 6-10-22 email. The CCI team has successfully completed numerous similar, environmental projects throughout the southeast US.

SCOPE OF WORK

VITAL has requested that CCI Environmental provide a quote for the following:

- 1. The site has an existing 2.5k diked AST that they want removed. (The shed the tank is in will be gone by the time we get there)
- 2. Pump the fuel out (assuming full), keep the fuel onsite while we set the new tank, then pump the fuel back in the same day.
- 3. After pumping out the tank, we need to clean it, load it on the disposal truck, and dispose.

CCI will utilize the vacuum truck, and pressure washer to complete removal of product, cleaning, and preparation of the tank. Once the tank is empty and clean, the vessel will be loaded onto a trailer utilizing an excavator and transported offsite for proper management. All CCI employees are trained in Hazardous Waste and Emergency Response Operations in accordance with 29 CFR 1910.120. Each employee is subject to medical monitoring in addition to drug and alcohol screening.

- Payment terms are net 30 days from receipt of invoice.
- Assume adequate space to utilize a large excavator and direct load on a flatbed trailer.
- Prices are based on performing work on non-holiday weekdays during normal business hours (7:00am 5:00pm, Monday Friday).
- CCI will retain all scrap or salvage value.
- Additional project work not specifically addressed by this estimate shall be charged at a time and materials rate. Any additional work, if required, shall be authorized by the customer prior to initiation.
- Assumes steel tanks with no insulation.
- Client is responsible for disconnecting all electrical connections to the tanks.
- CCI Environmental will not be held responsible for any damages to asphalt and/or concrete pavement due to the use of heavy equipment.
