The review process can take several weeks, so the applicant should be patient.

After the application has been reviewed, the applicant will be notified of the results. If the applicant is successful, they will be invited to an interview. The interview is an opportunity for the employer to ask the applicant more questions and to see if they are a good fit for the position. If the applicant is not successful, they may be able to re-apply at a later date.
