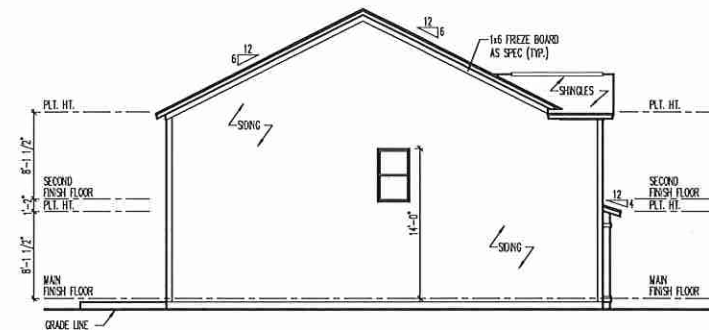


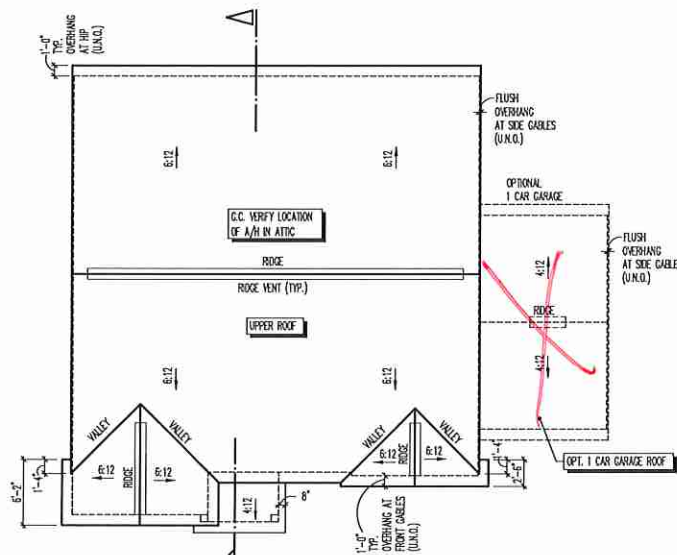

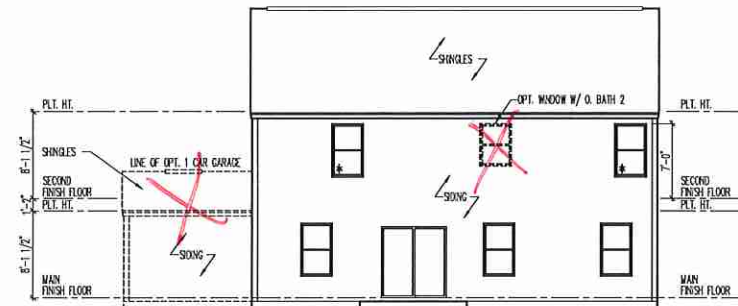


ROOF PLAN
