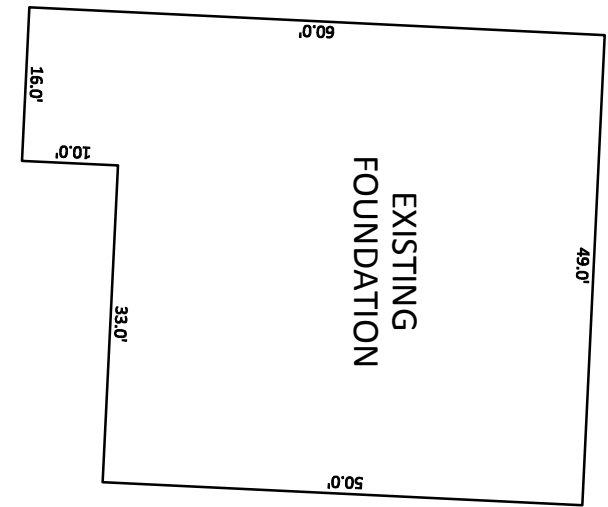

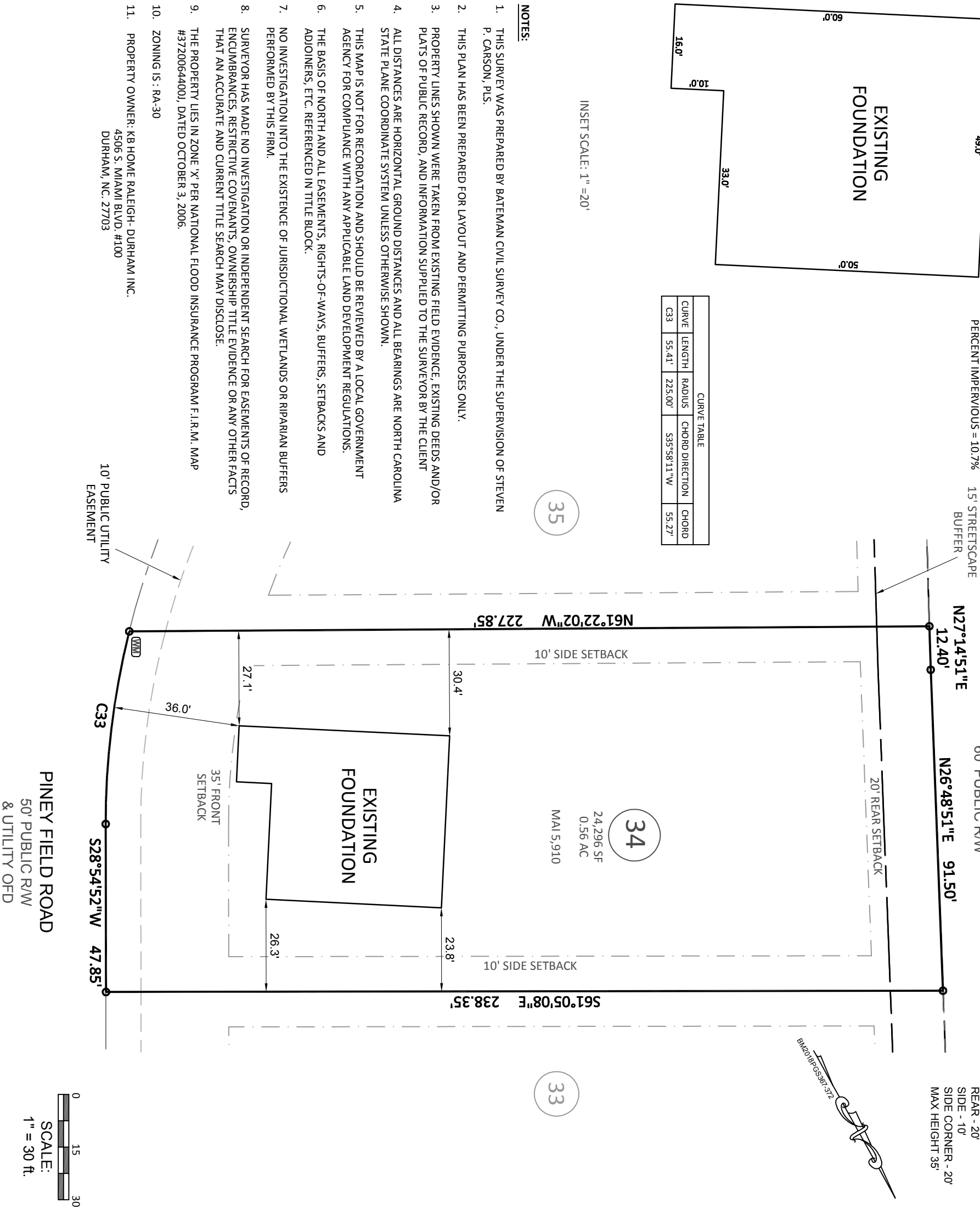

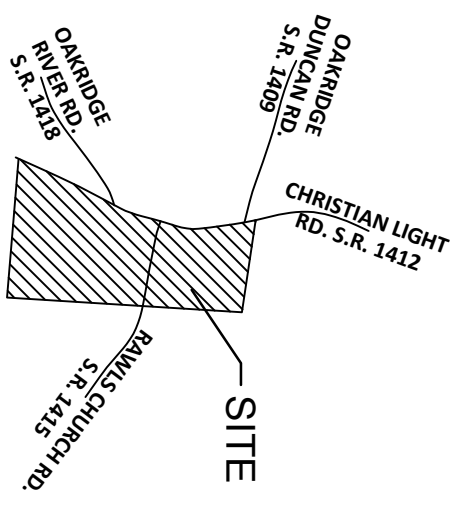

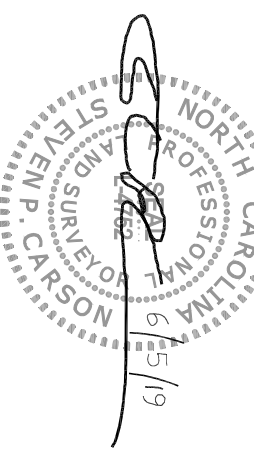


**VICINITY MAP**
