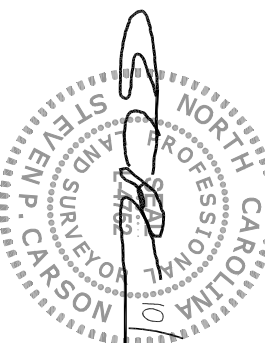
VICINITY MAP
