DORMAN FARM, INC., a North Carolina Corporation with its principal office in Harnett County, North Carolina

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

TRACT I: Land lying and being in Harnett County, North Carolina and more particularly described as follows:

FIRST TRACT: BEGINNING at a sycamore on the Southwest bank of Cape Fear River, a corner of H. F. Page's land and the land belonging to the Estate of S. C. Page, deceased, and runs as that line to and past H. F. Page's corner South 88 East 4545 feet to an iron stake corner for Mrs. Warren; thence as her line North 4.45 East 1197 feet to an iron stake driven in a pine stump; thence as that line North 5.30 East 868 feet to the center of a big gully; thence down the said gully North 68.55 West 83 feet; thence North 55.30 West 140 feet; thence North 58 West 80 feet; thence North 24.15 West 114 feet; thence North 60.30 West 140 feet; thence North 624.15 West 140 feet; thence North 60.30 West 140 feet; thence North 60.30 feet to where the said gully empties into Cape Fear River; thence down th said Cape Fear River, as it meanders, to the BEGINNING, containing 162.5 acres. West 3143 feet to the

TRACT III: Land lying and being in Black River Township, Cumberland County, North Carolina and more particularly described as follows:

All that certain piece, parcel or tract of land containing 50 acres more or less, situate, lying and being on the old Raleigh and Fayetteville Stage Road, about 3 miles North from the Town of Godwin in Black River Township, County of Cumberland, State of North Caroline, having such shapes, metes, courses and distances as will more fully appear by reference to a plat thereof, made by William T. Smith, C. E., March 1922 and attached to the abstract now on file with the Federal Land Bank of Columbia, the same being bounded on the north by lands of W. T. Warren, on the east by lands of Edward Purdie, and J. D. McPhail, on the south by lands of E. E. Godwin, and on the west by lands of Miss Alberta Robertson.

Said deeds were acknowledged by all Grantors before a rotary public and it may have been required at that time that the female Grantor execute said deeds pursuant to N. C. General Statute 52-6, which statute was repeated effective January 1, 1978.
