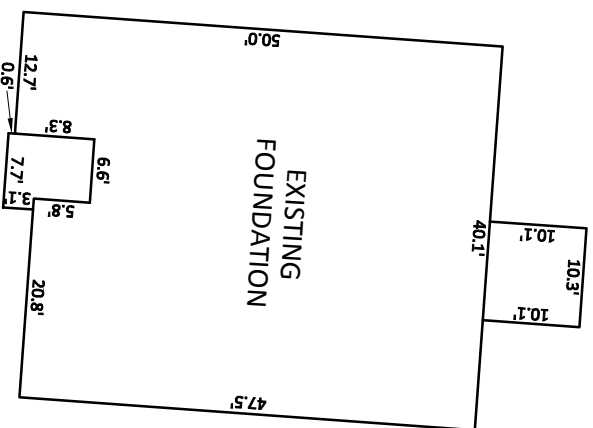

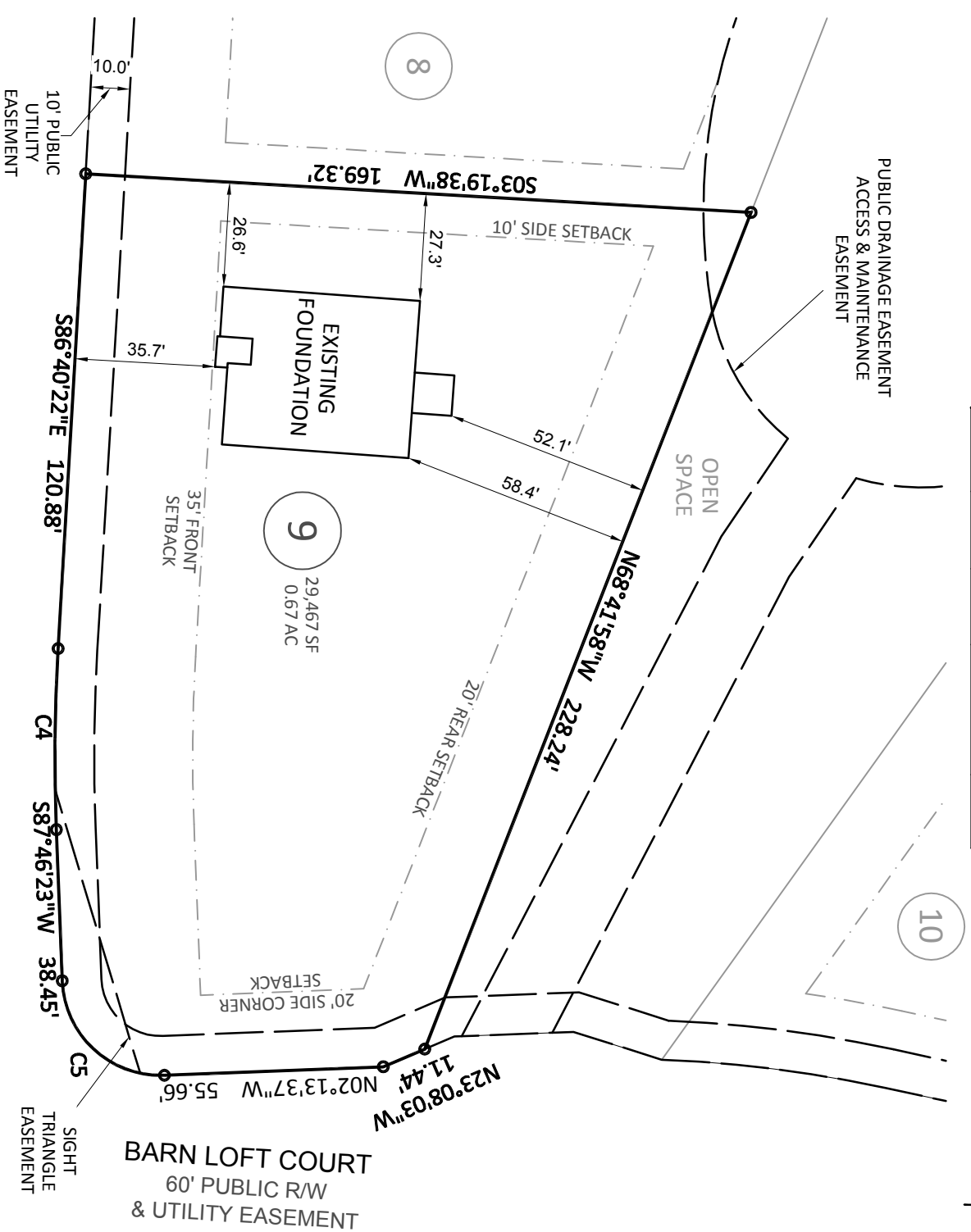

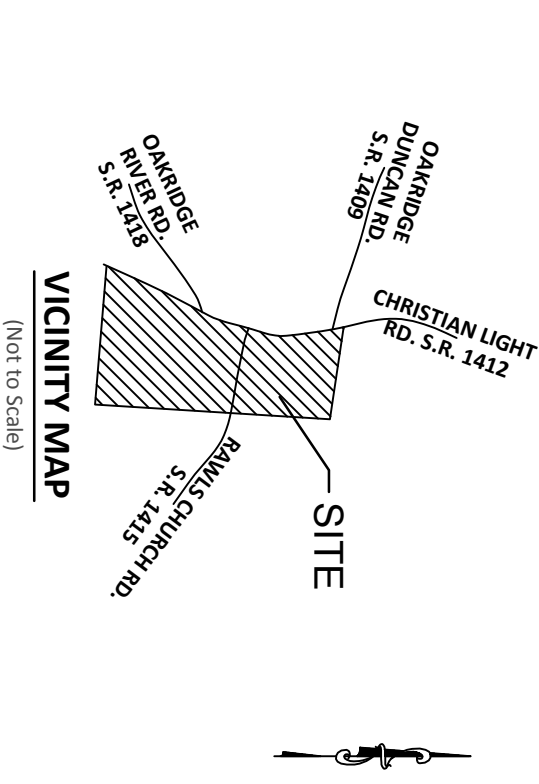

**VICINITY MAP**

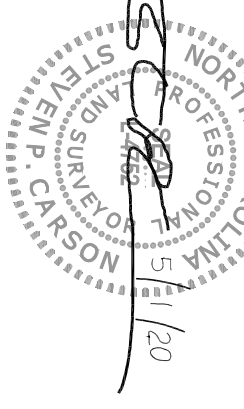
