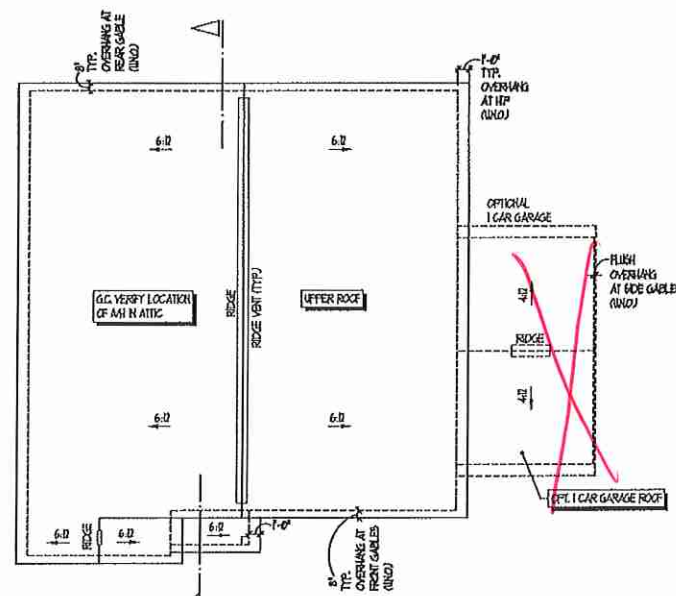

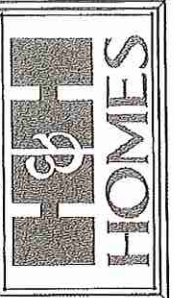

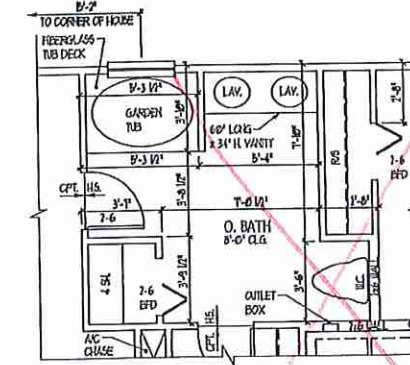

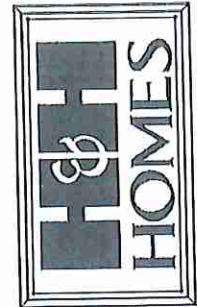


**BEDROOM 4 OPTION**
