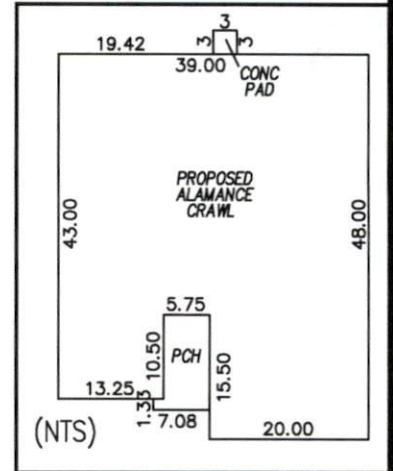
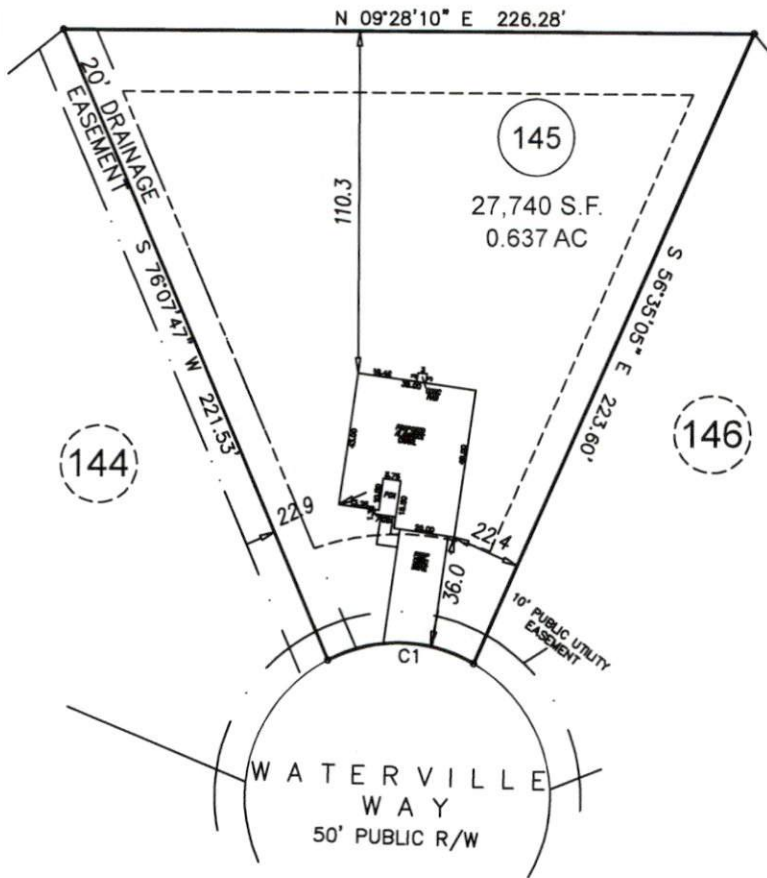


SITE VICINITY MAP (NTS)

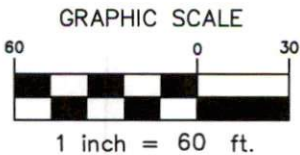
