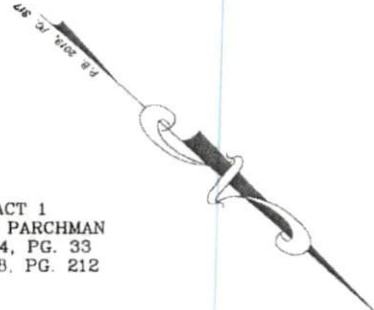


VICINITY MAP

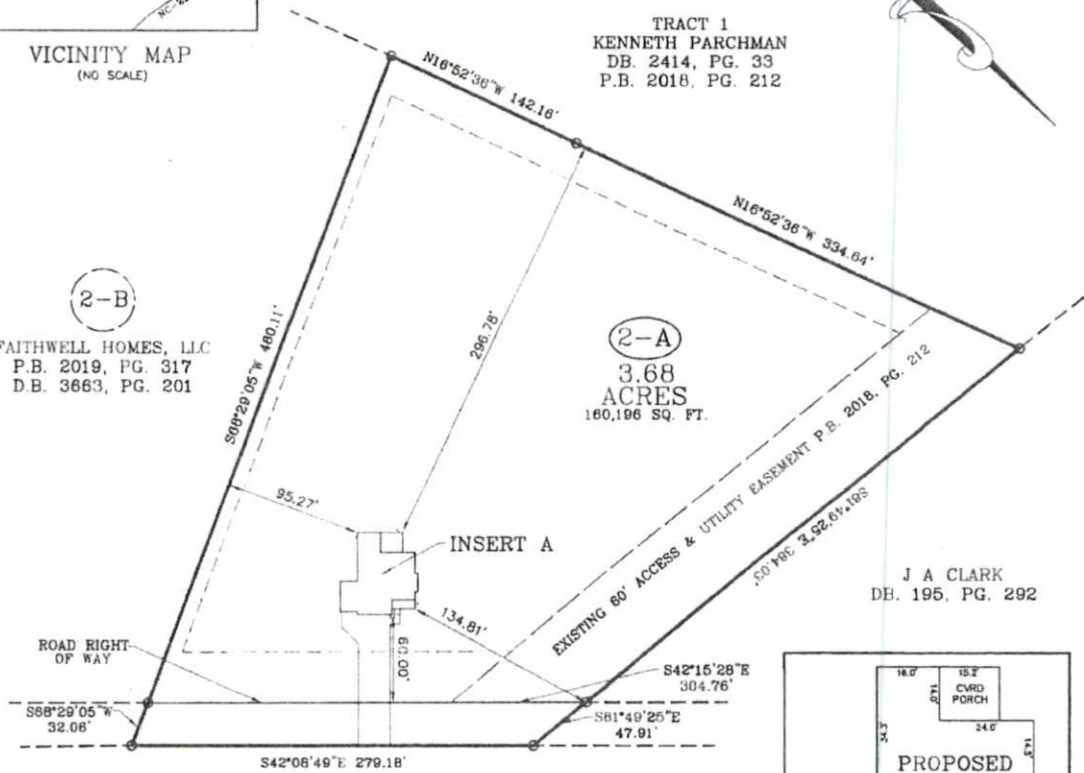

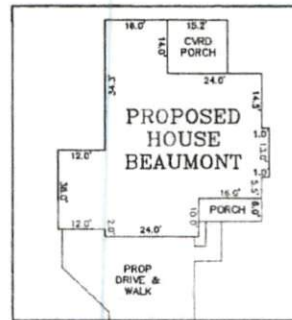

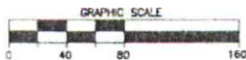
