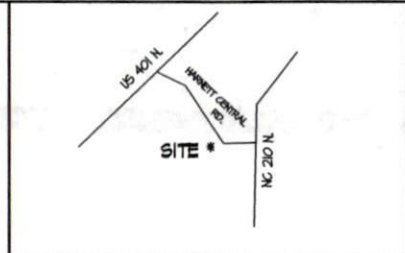

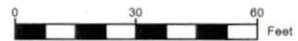
VICINITY MAP
