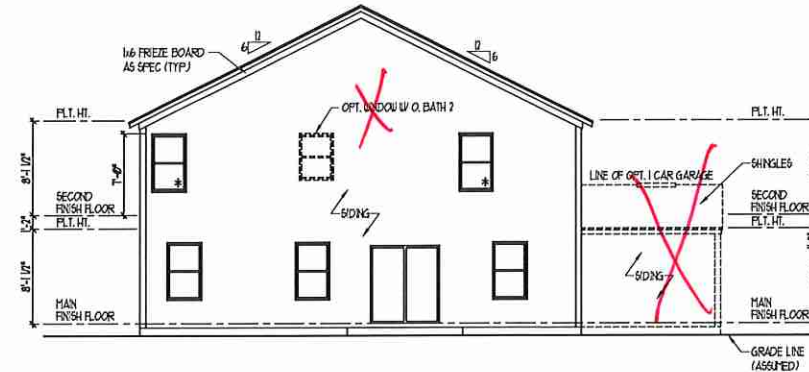
**ELEVATION "C" - MODERN**

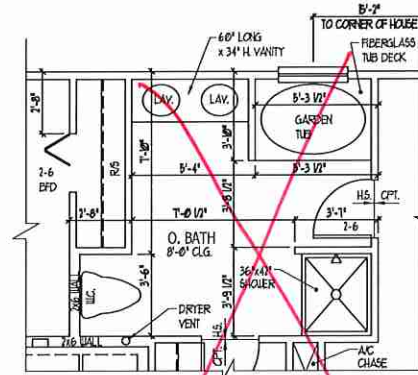
UPPER FLOOR PLAN

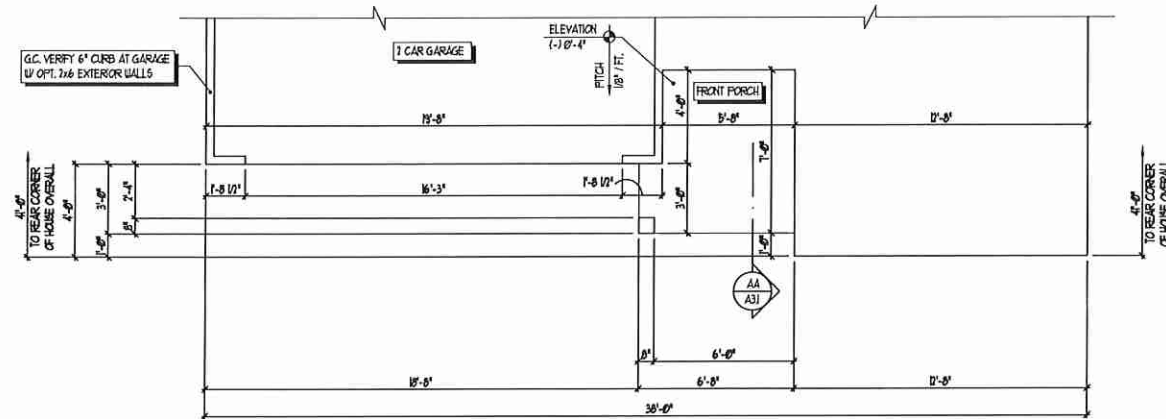
PARTIAL UPPER FLOOR PLAN

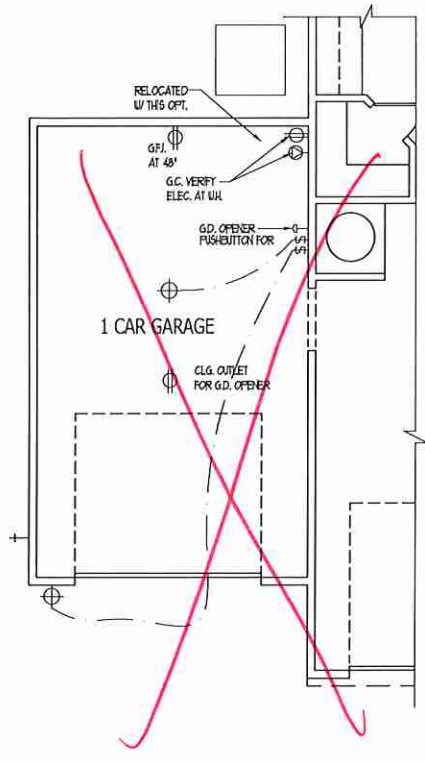

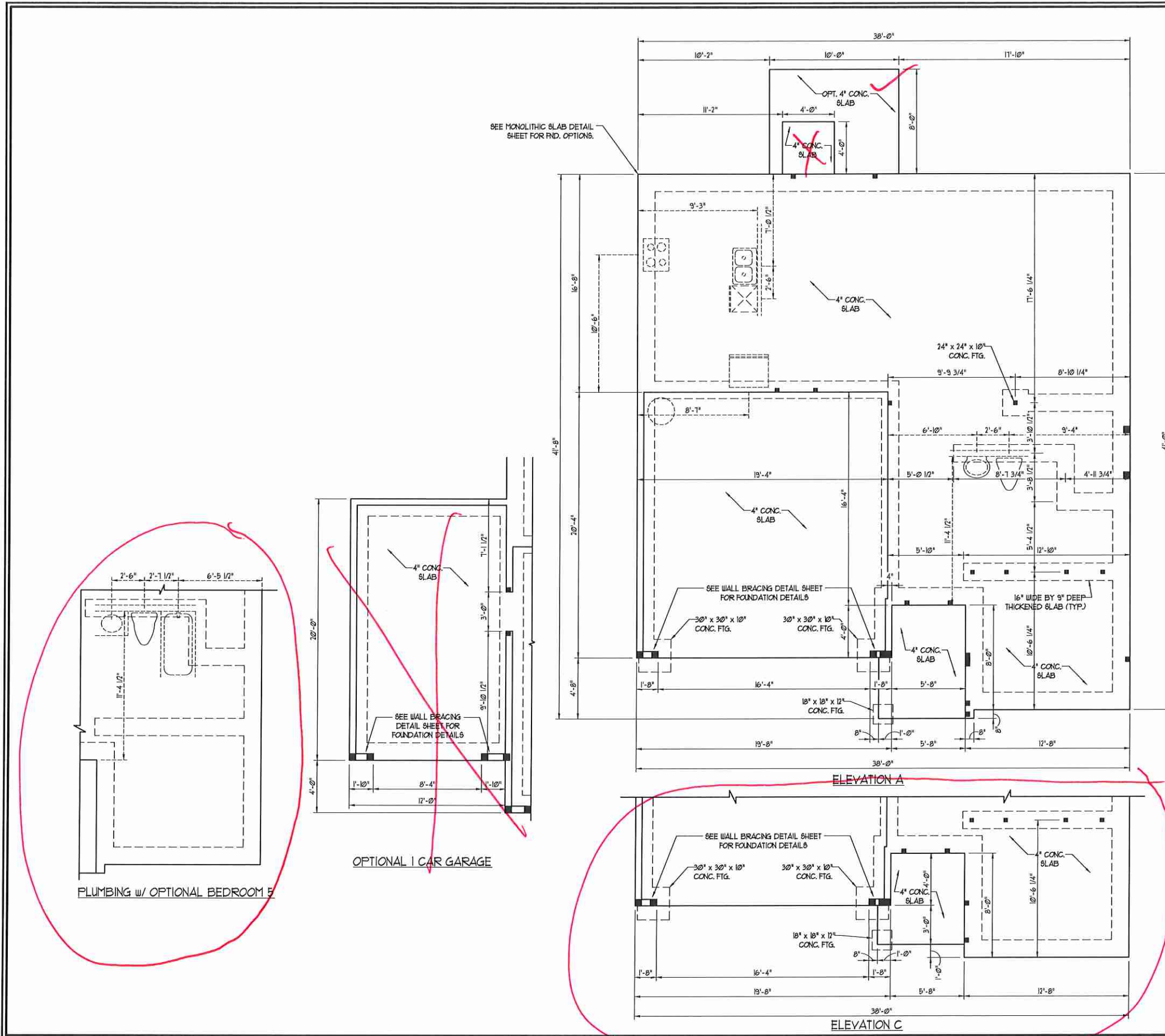
