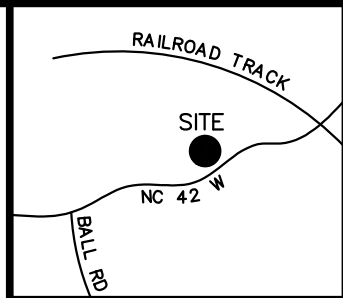

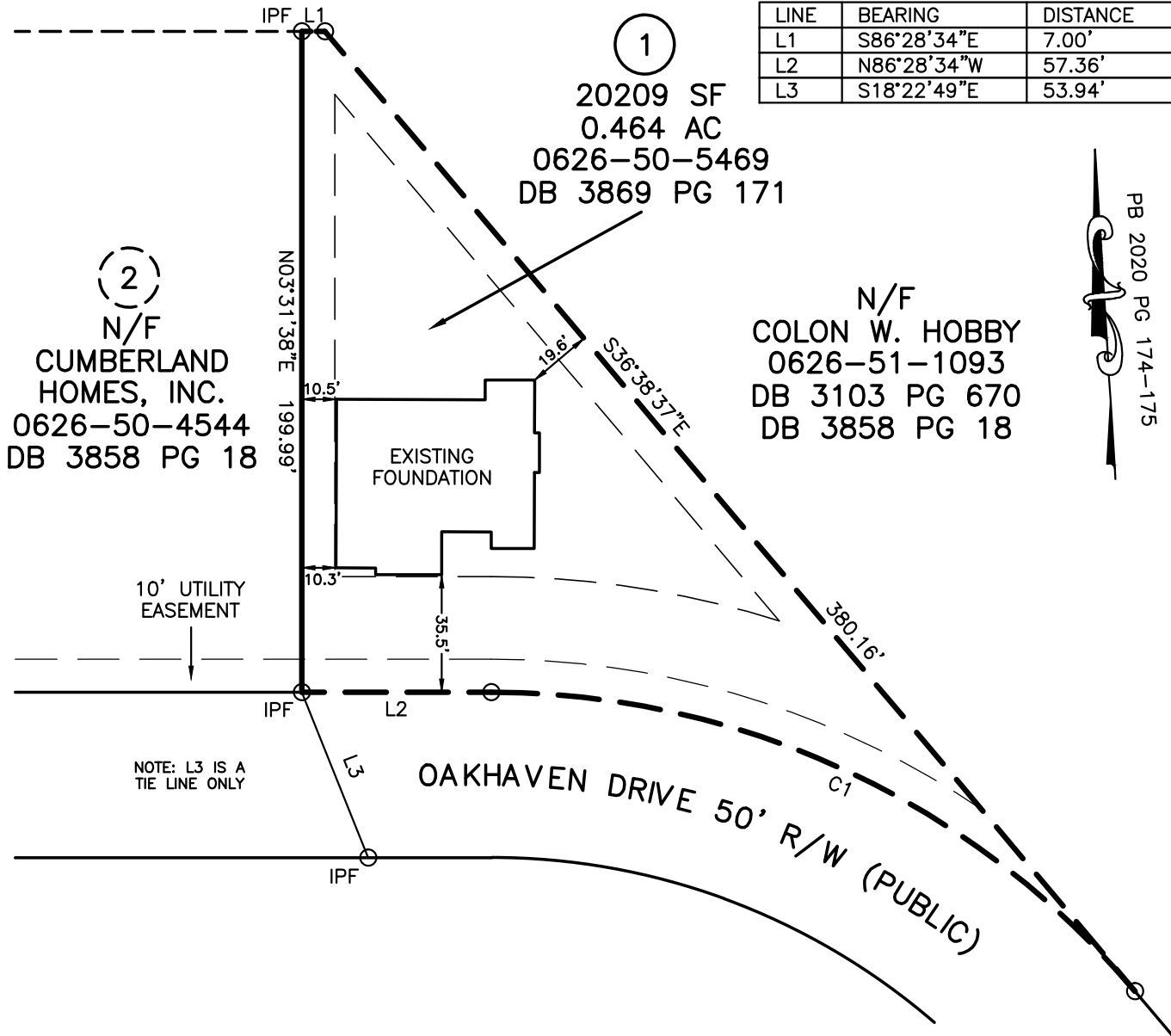
VICINITY MAP

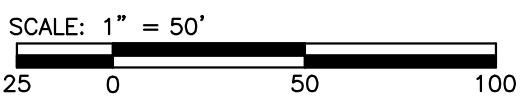
