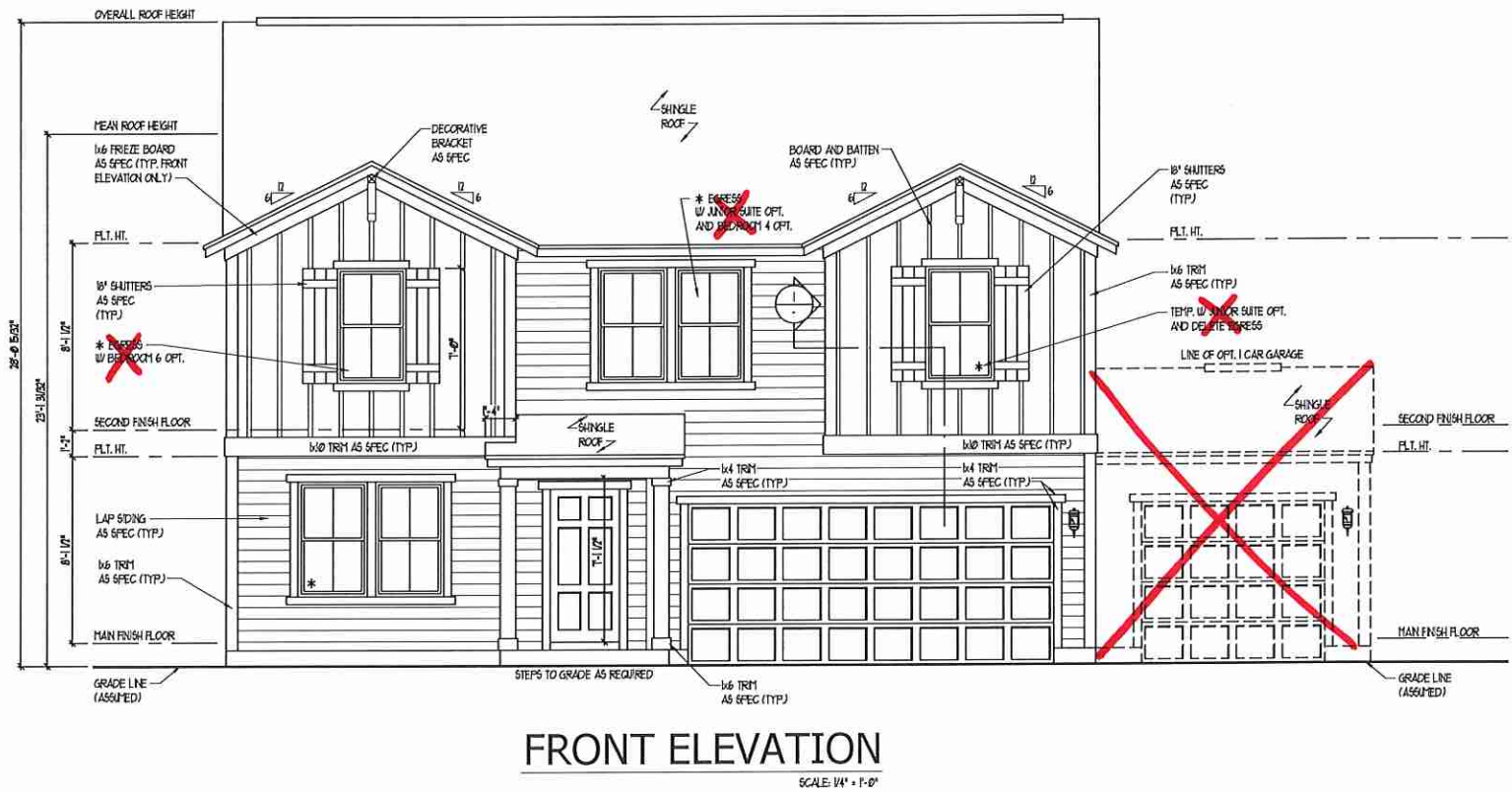
BRACKET DETAIL

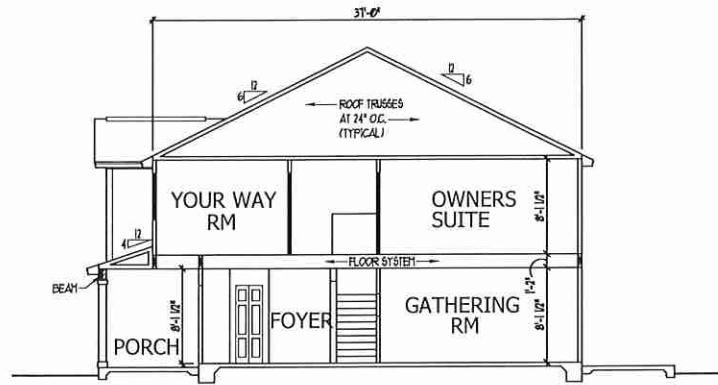

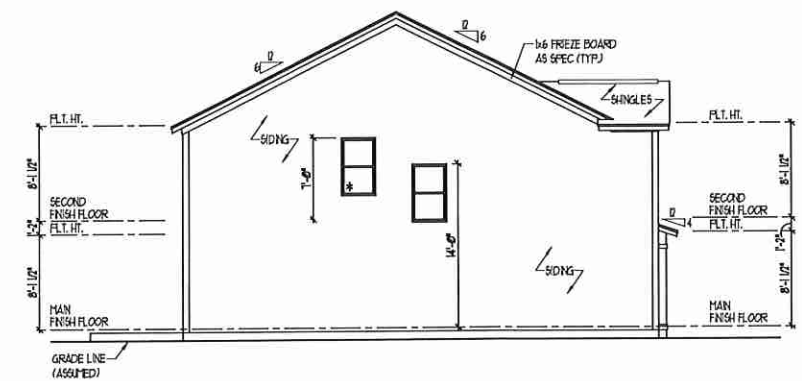

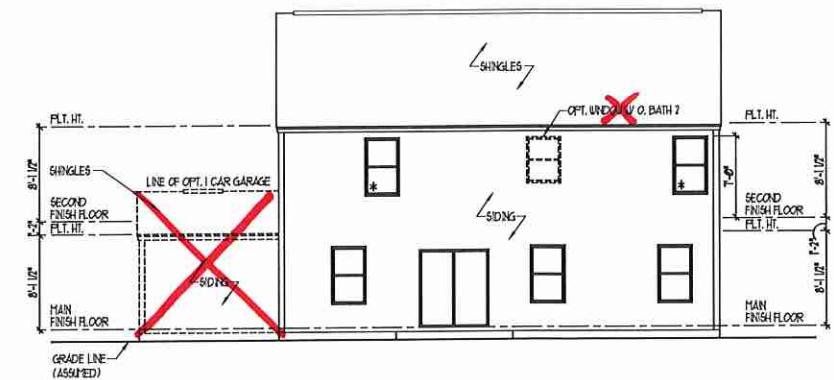
ELEVATION "A" - TRADITIONAL
 GARAGE RIGHT



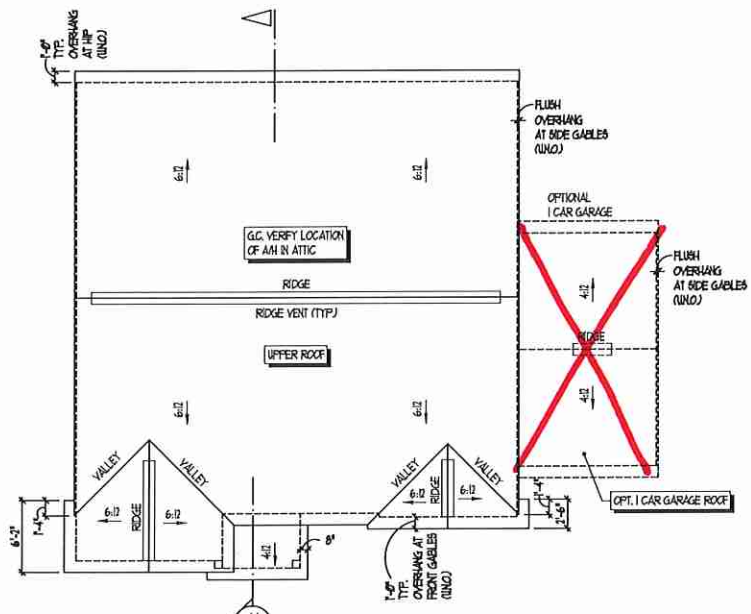

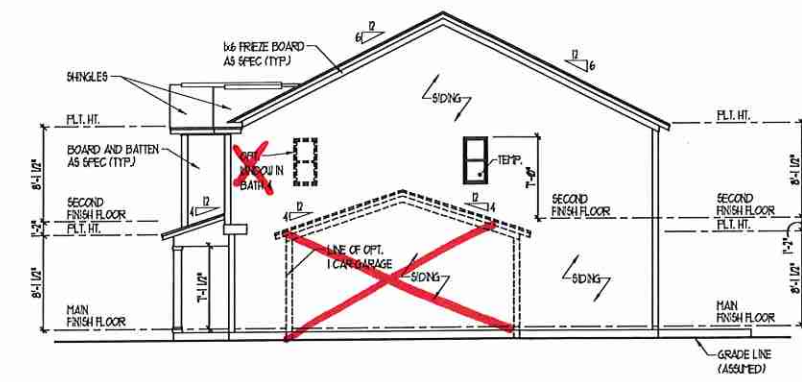

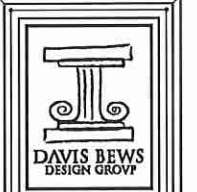


RIGHT ELEVATION

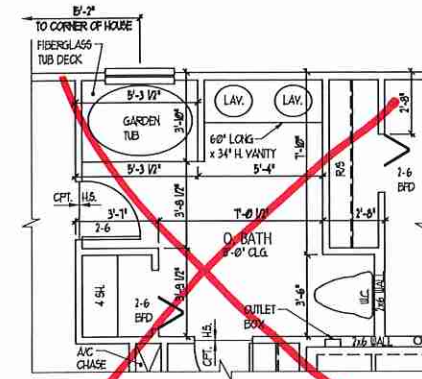
UPPER FLOOR PLAN

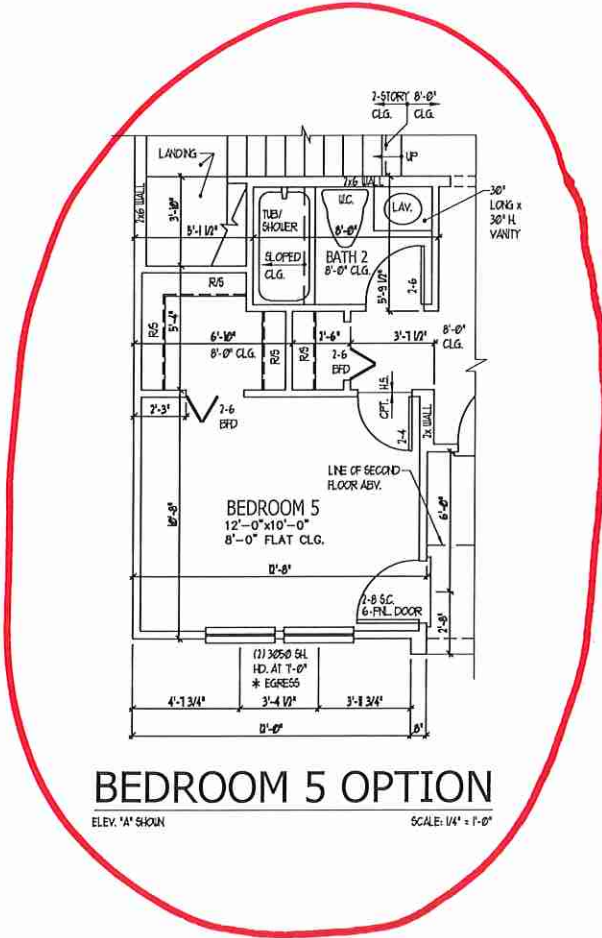
BEDROOM 6 OPTION

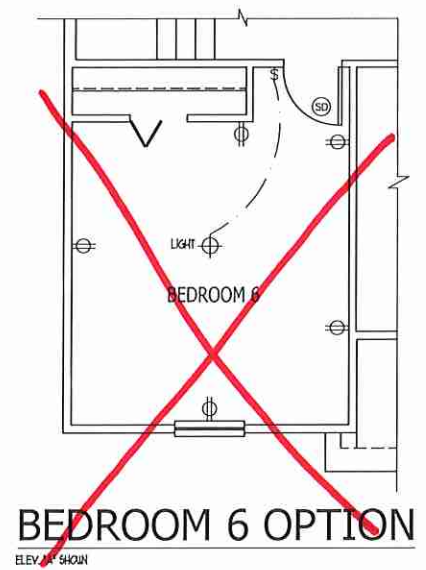
UPPER FLOOR ELECTRICAL PLAN
