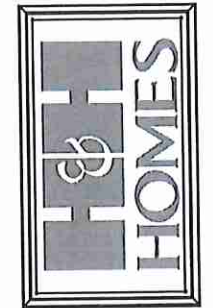

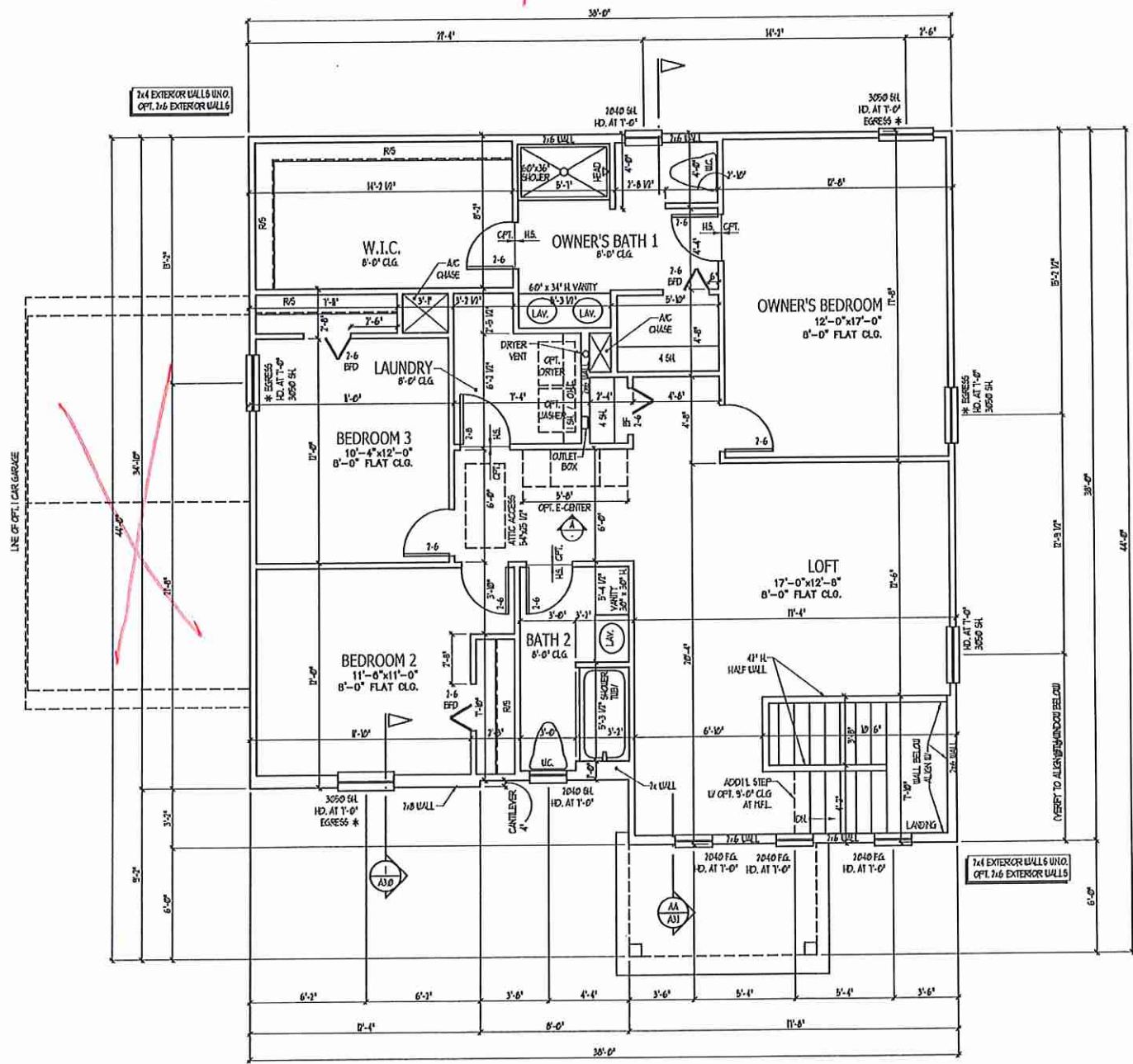
PARTIAL UPPER FLOOR PLAN - C

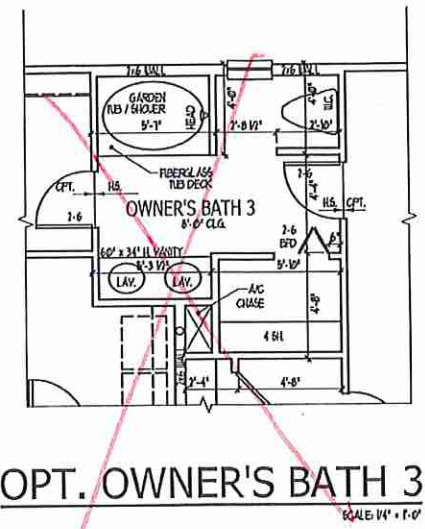

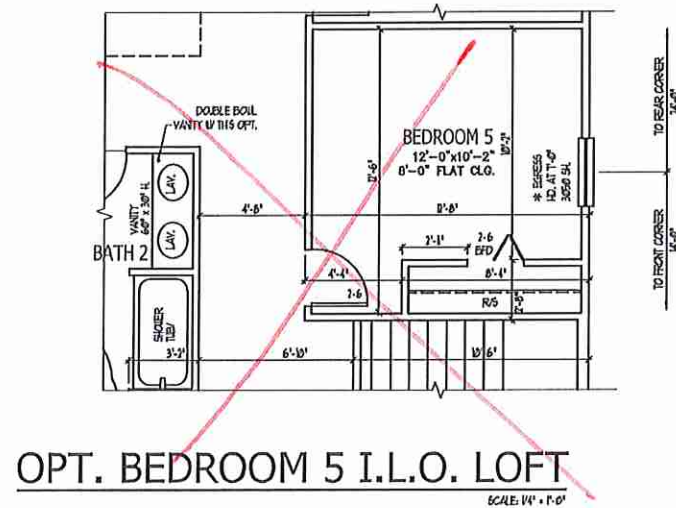
OPT. PATIO

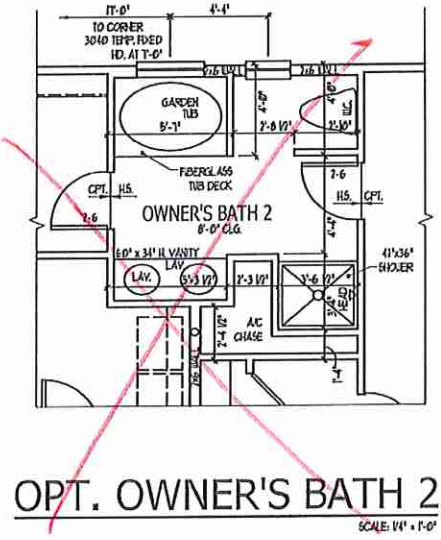
OPT. BEDROOM 4 W/ BATH 3

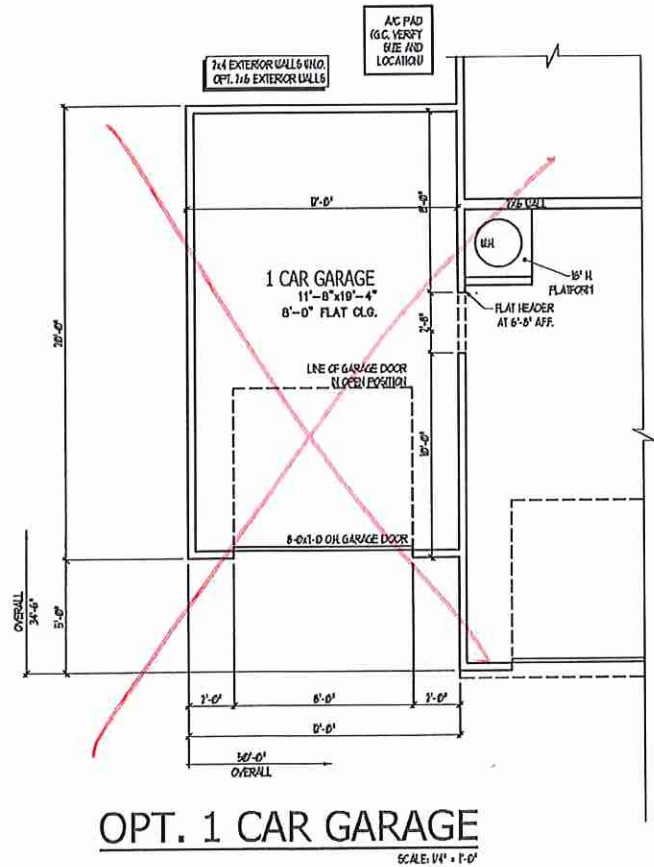
OPT. OWNER'S BATH 3

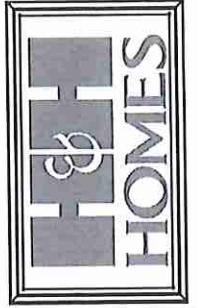


OPT. OWNER'S BATH 2

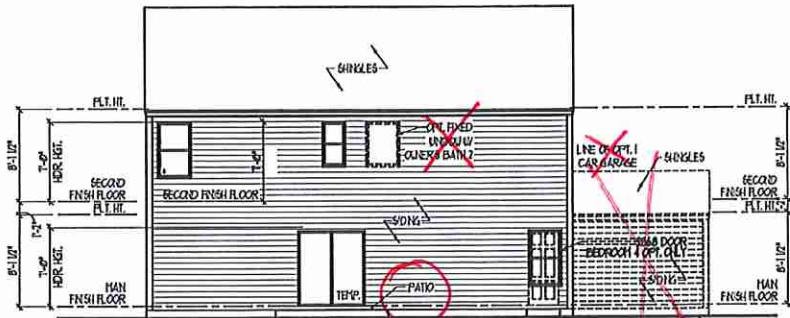

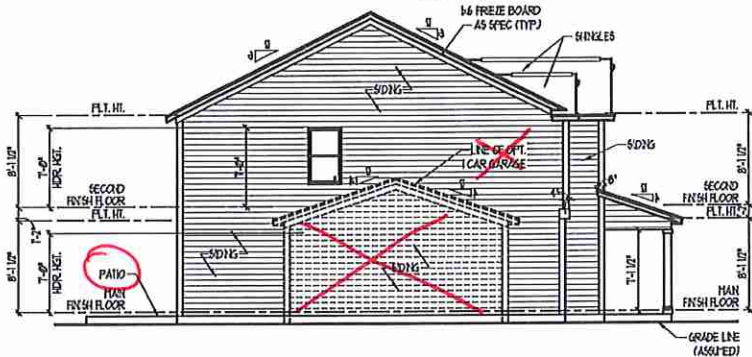

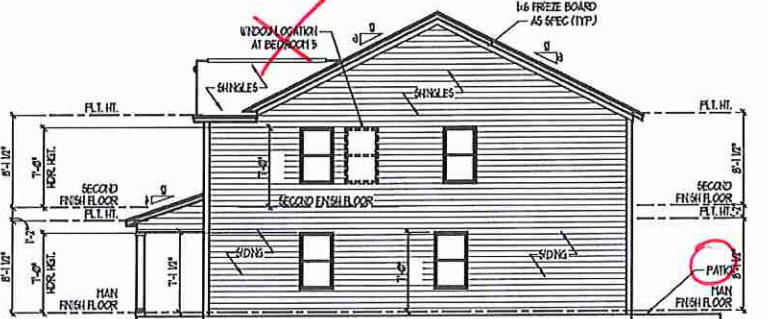
REAR ELEVATION

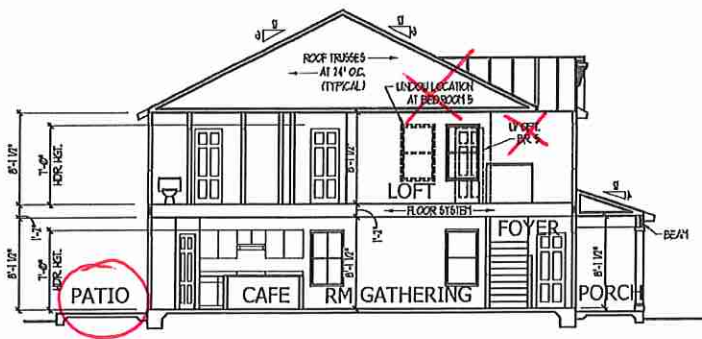
LEFT ELEVATION

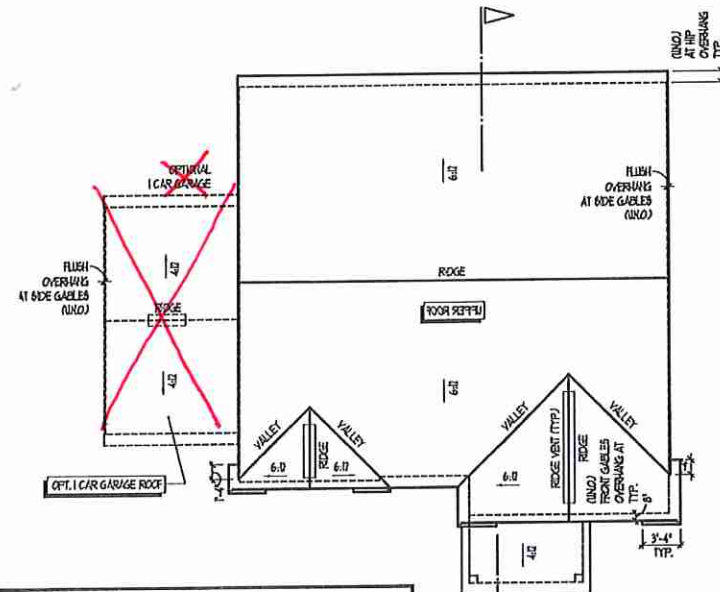

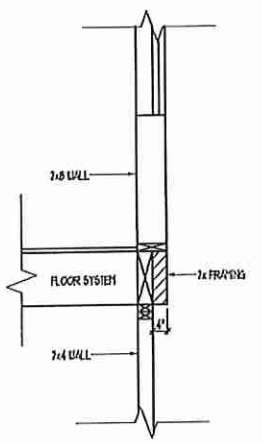
FRONT ELEVATION

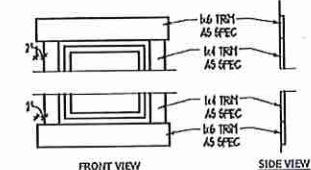
ROOF PLAN

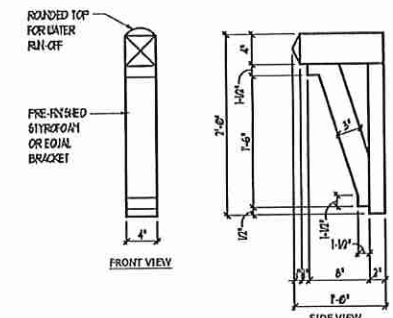
CANTILEVER DETAIL 1
