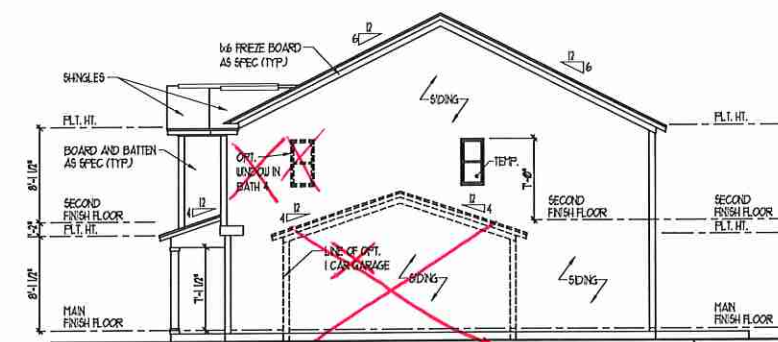


ROOF PLAN

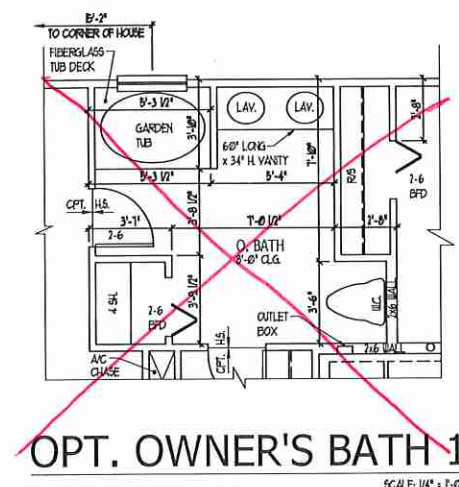
UPPER FLOOR PLAN

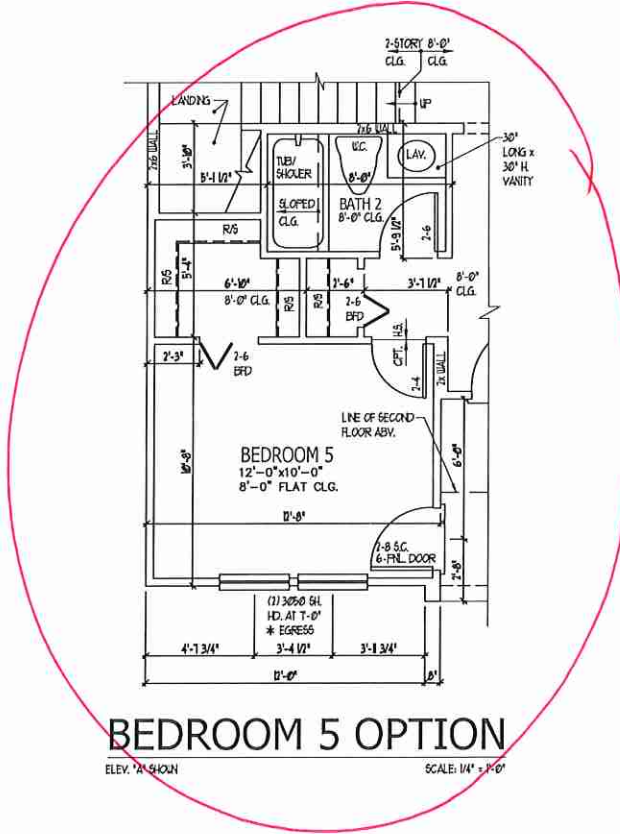
BEDROOM 6 OPTION

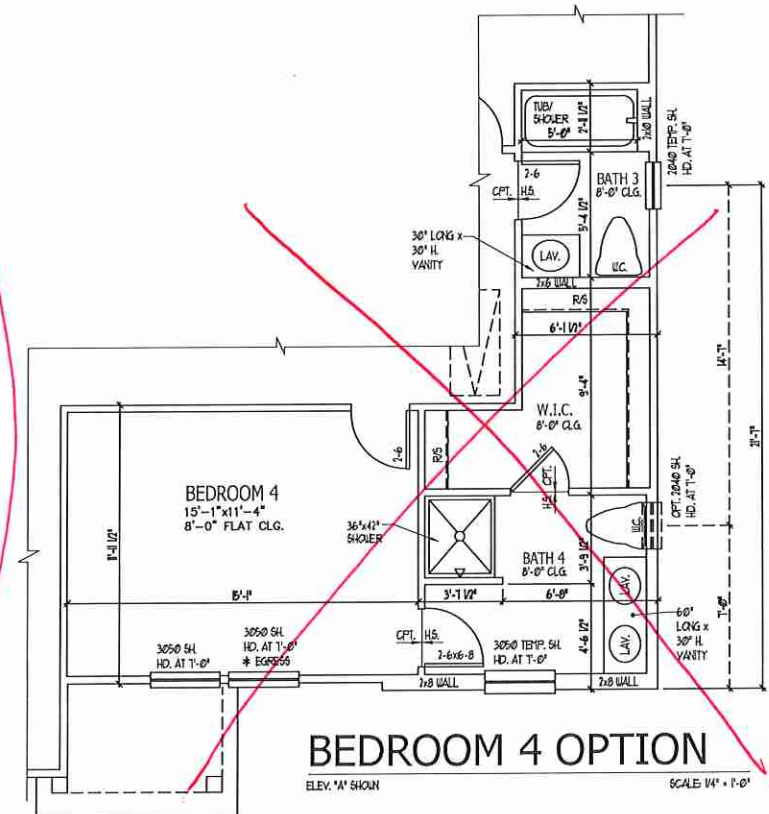

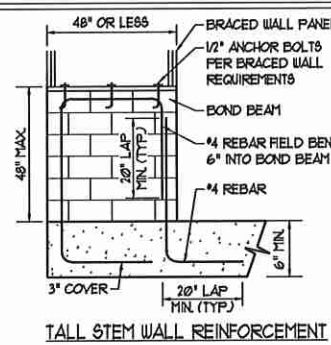

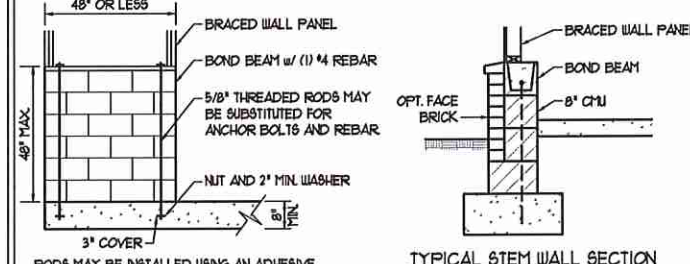

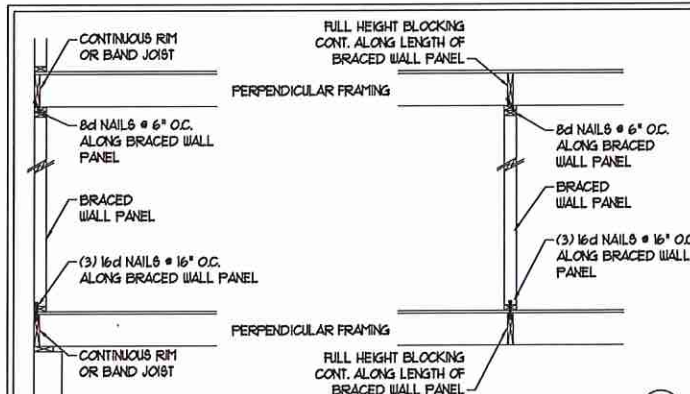

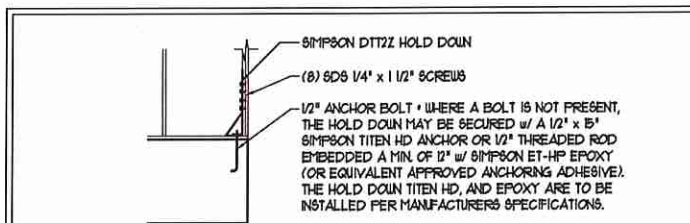

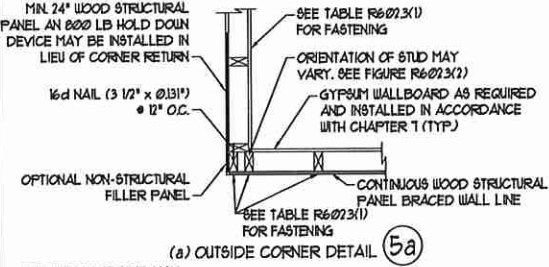

(a) OUTSIDE CORNER DETAIL ⑤a



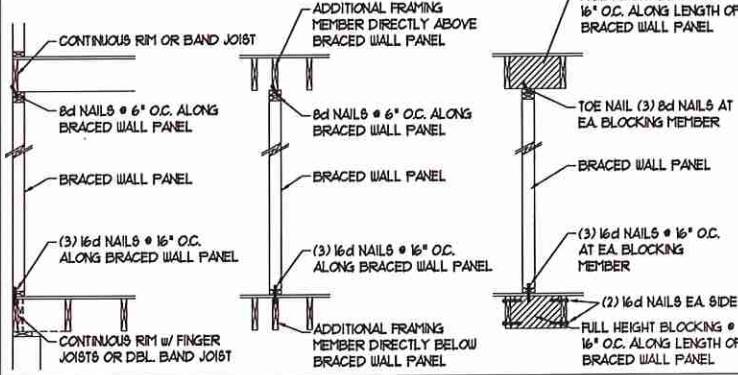

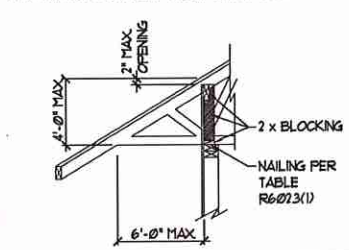

BRACED WALL PANEL CONNECTION TO PERPENDICULAR ROOF TRUSSES ⑨

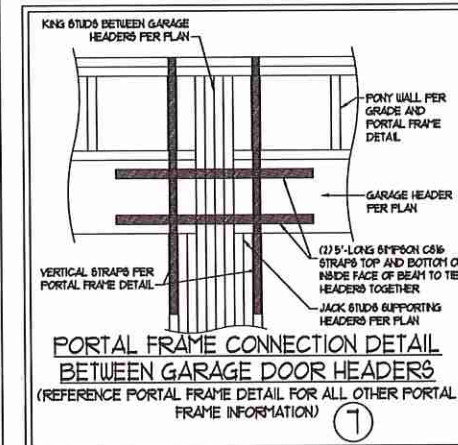

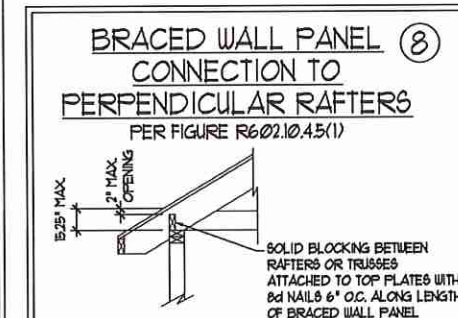
