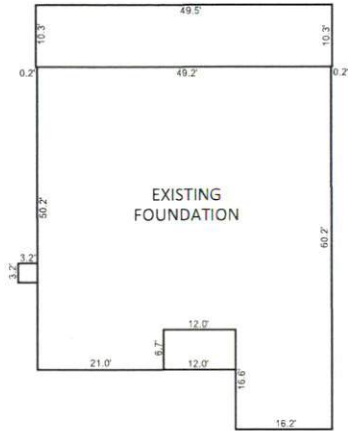

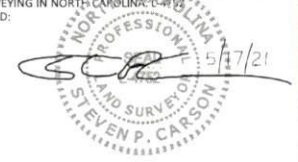


VICINITY MAP
