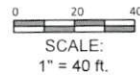
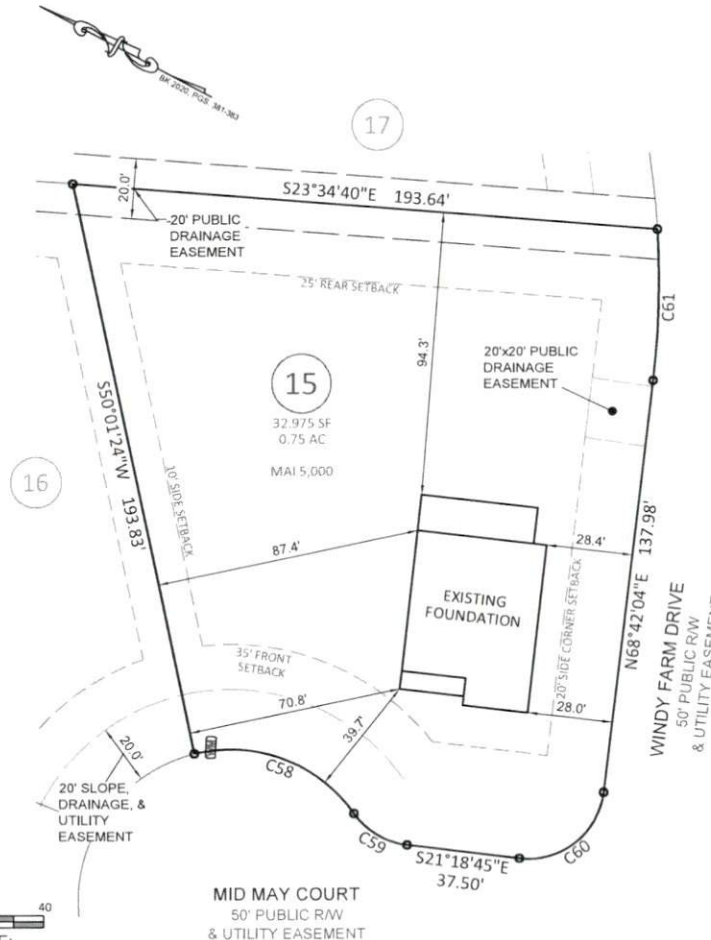


VICINITY MAP

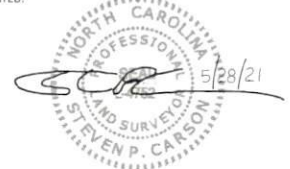
