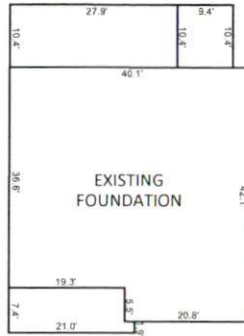

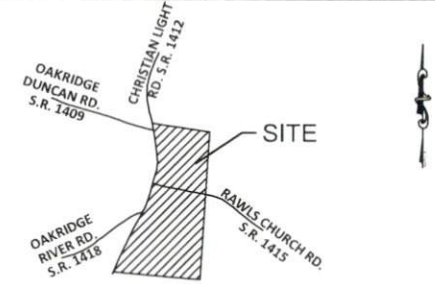

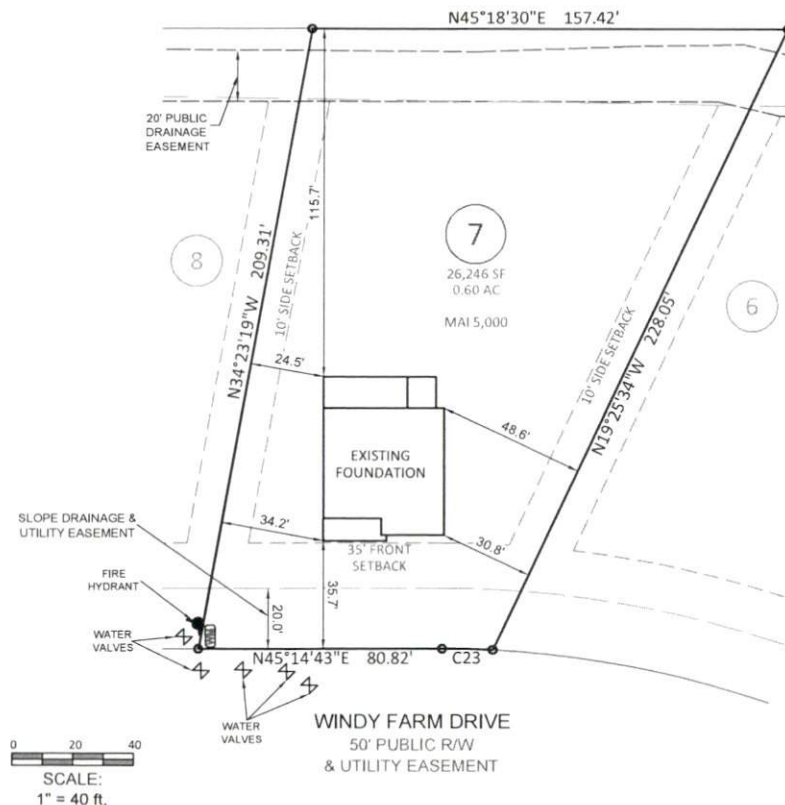


VICINITY MAP
