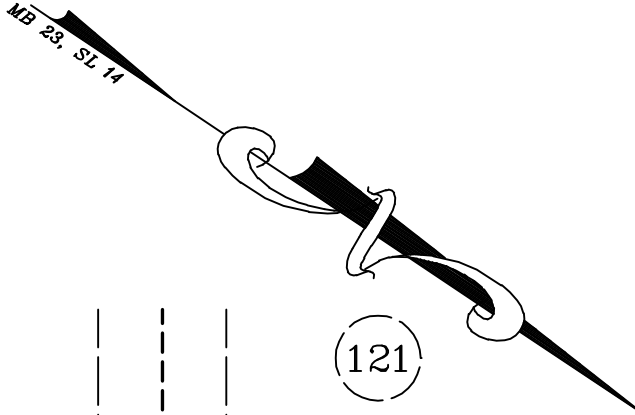


VICINITY MAP

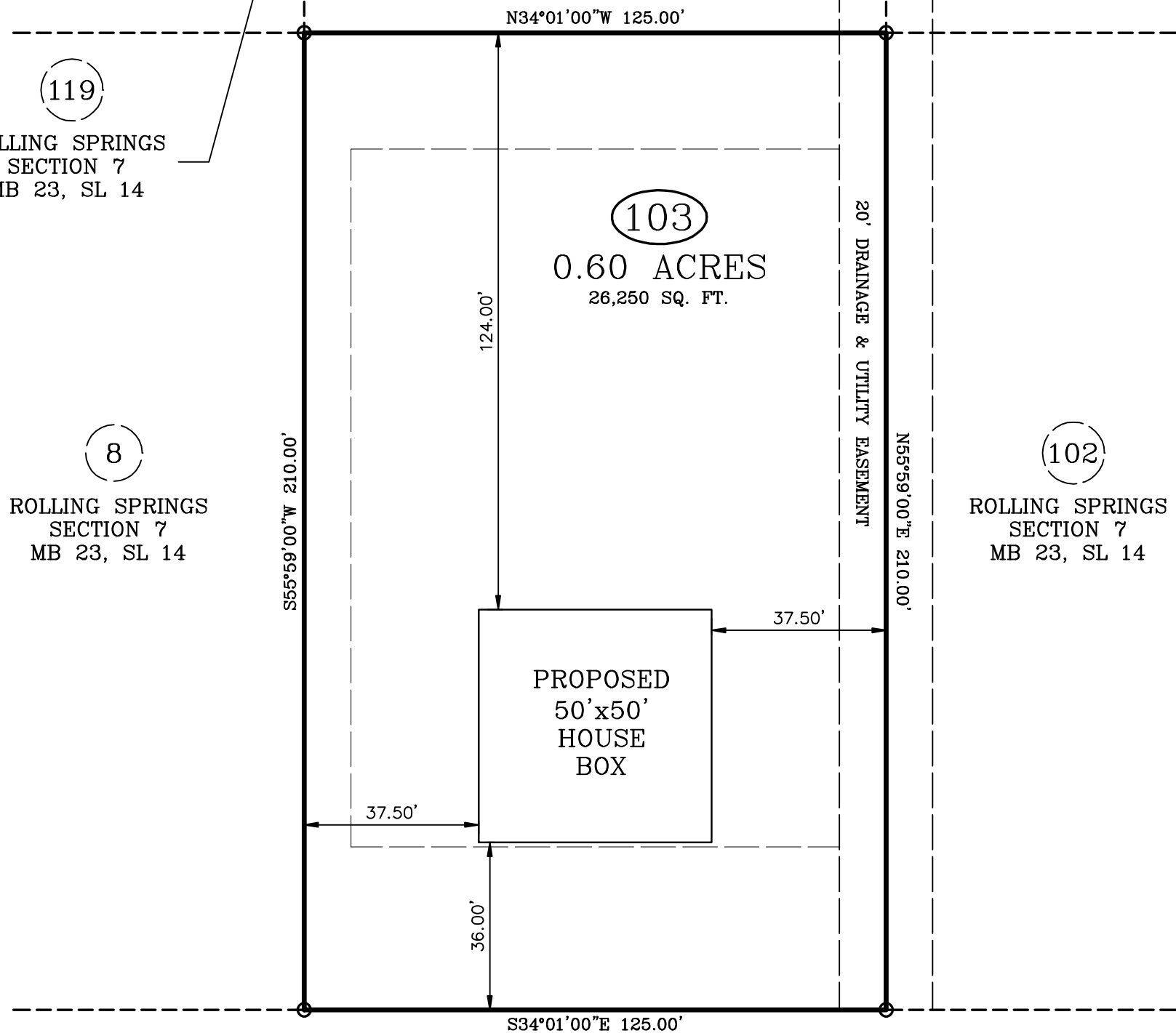

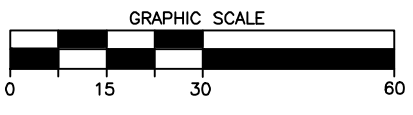
