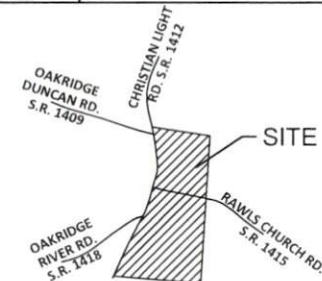

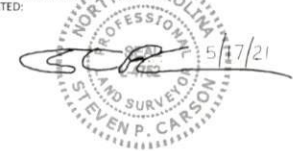
VICINITY MAP

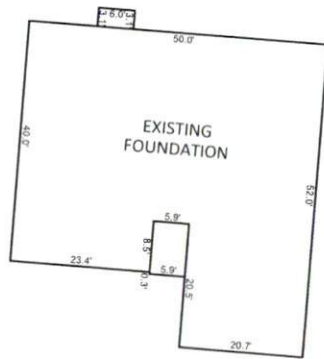

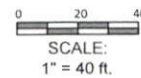
