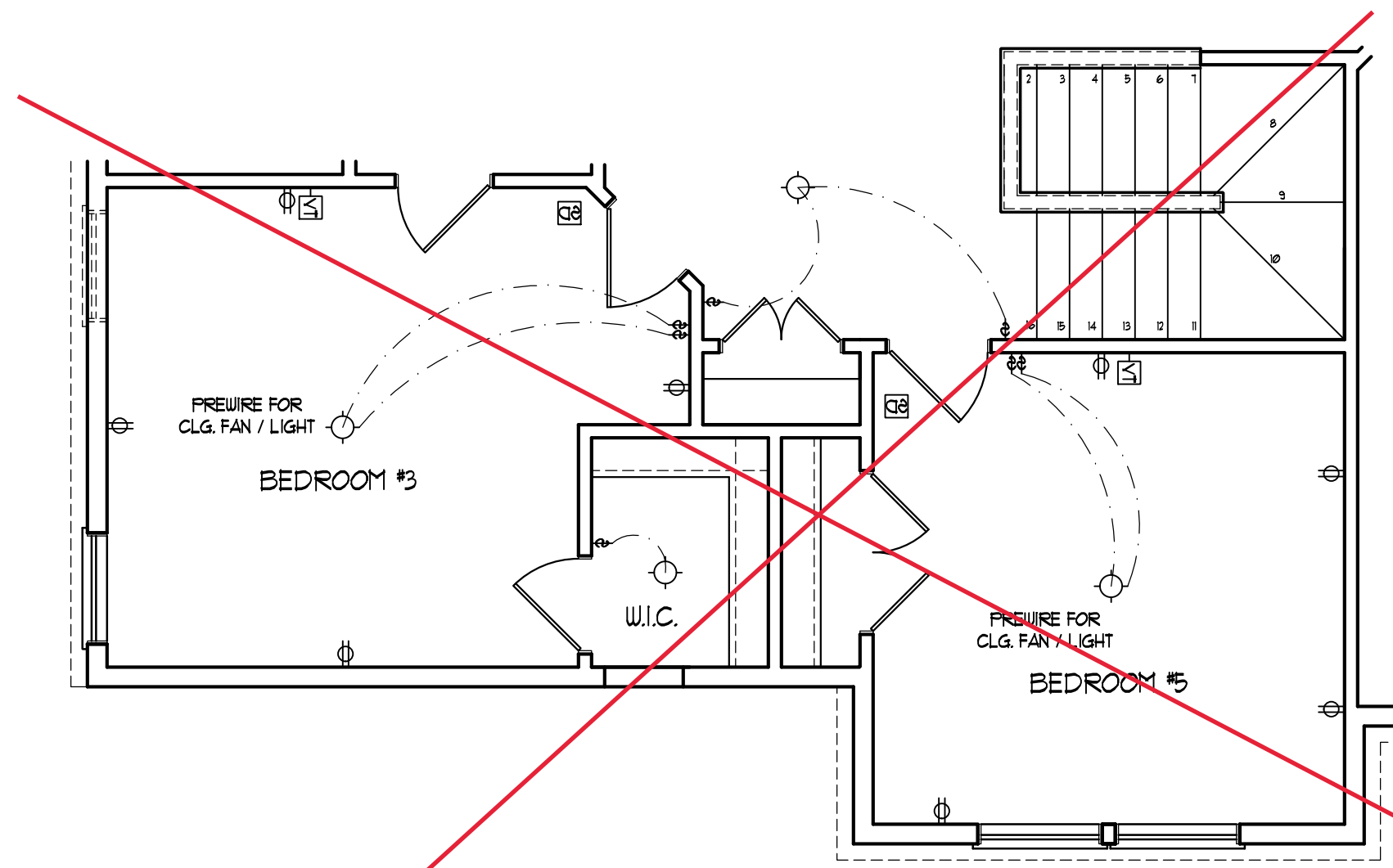
BEDROOM #5 OPTION



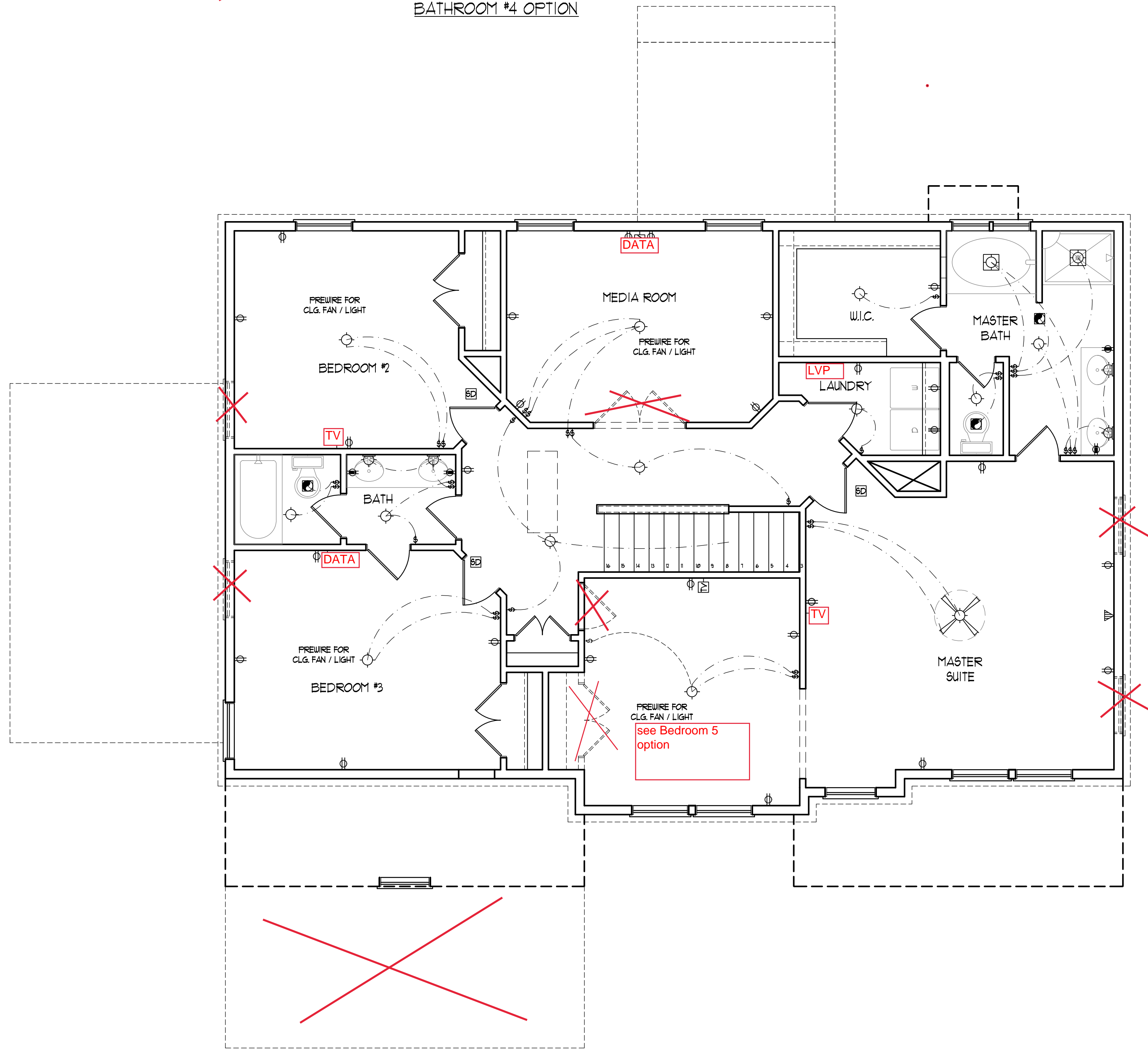

SF STAIRS W/ BASEMENT OPTION



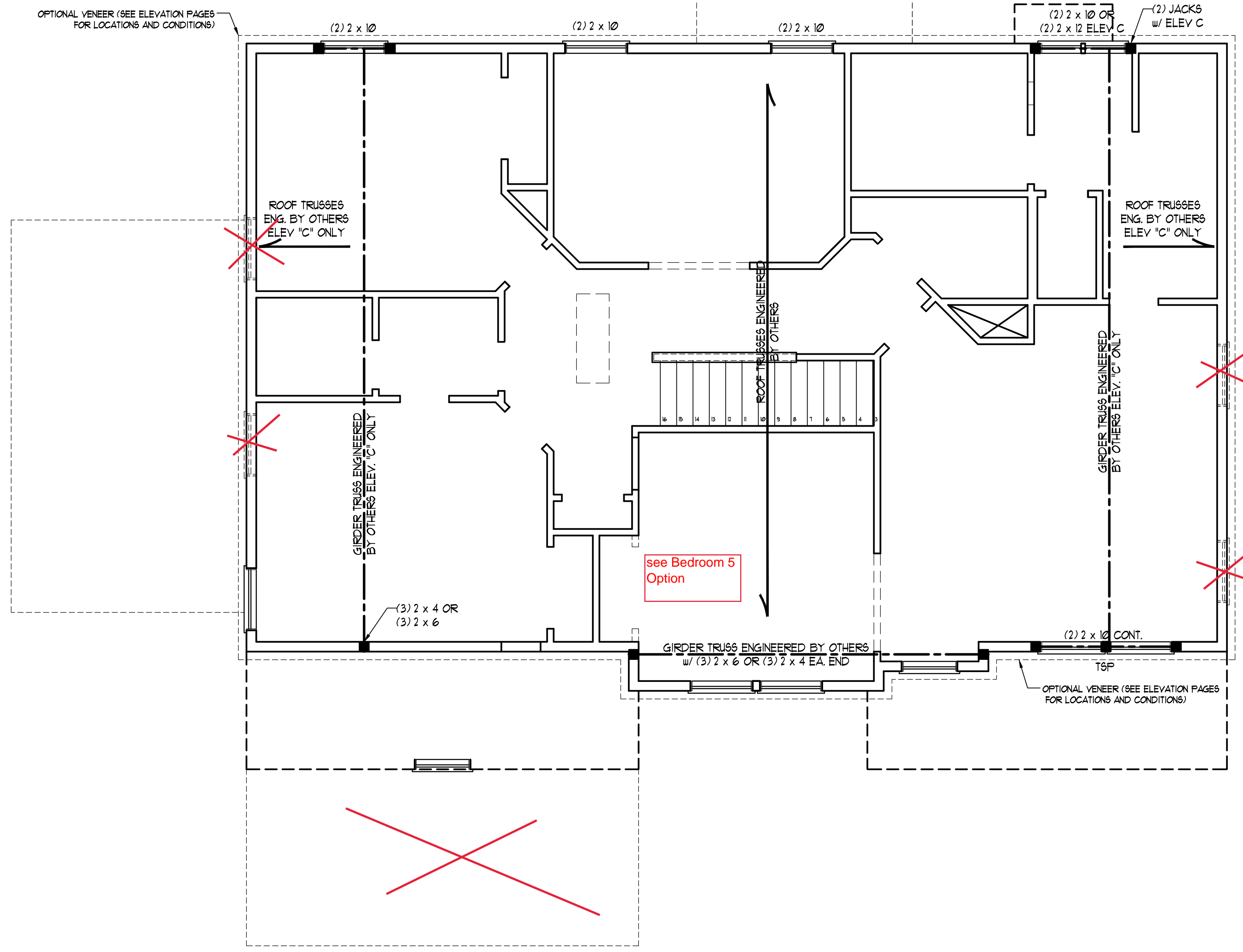
