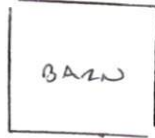

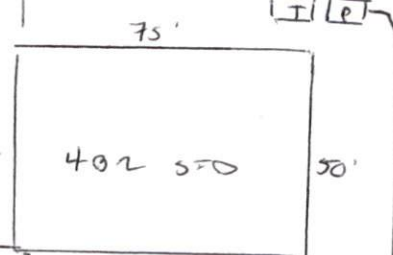
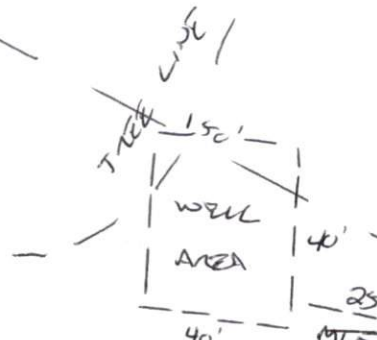

DRIVEWAY AS HIGH UPHILL AS POSSIBLE

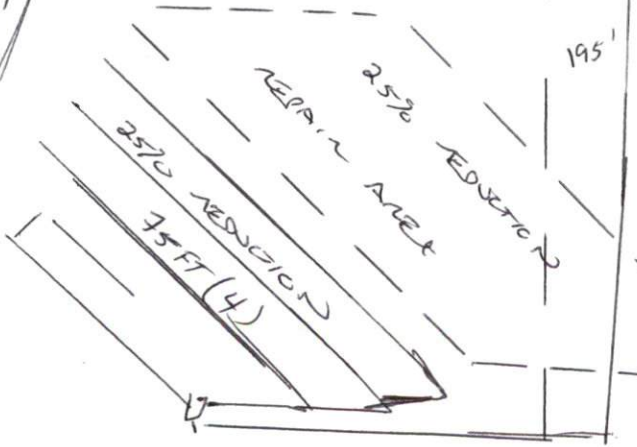
