Footings were 24" X 8" minimum. Probed footings and found them capable of supporting an allowable soil bearing capacity of 2000 psf. Footings were free of loose soil and organics. This inspections includes 2 deck pier footings on back of home. This inspection does not include upper section of garage and front of home. This work was performed in accordance with accepted engineering practices as required by the 2018 North Carolina Residential Building Code. This area was approved for the placement of 3000 psi concrete.
