1. Portal frame bolts loose and a few anchor bolts in garage 2. Can't notch jack stud at bottom plate at portal bolt 3. Missing jack studs on both sides of garage header 4. Duct work needs to be protected at stairs 5. Mid point strap on plumbing line 6. Need approved fire stop at plumbing line in garage and missing at water closet next to garage, dryer vent pipe, left closet by stair 7. Need 100 psi on test8. Missing king under 9 1/4 lvl per plans9. Missing header over return and need to be boxed in 10. Missing king on fire place lvl right side 11. Notched front porch beam at kitchen window 12. Need to strap sc in front right bedroom front porch, 4sc in master 13. Need to add king on each side of master window 14. DWV no water in test 15. Air barrier need to be sealed upstairs 16. Missing window 17. Missing fire stop upstairs closet, behind shower Stopped inspection. Need to look at roof system and need layout for trusses in garage.
