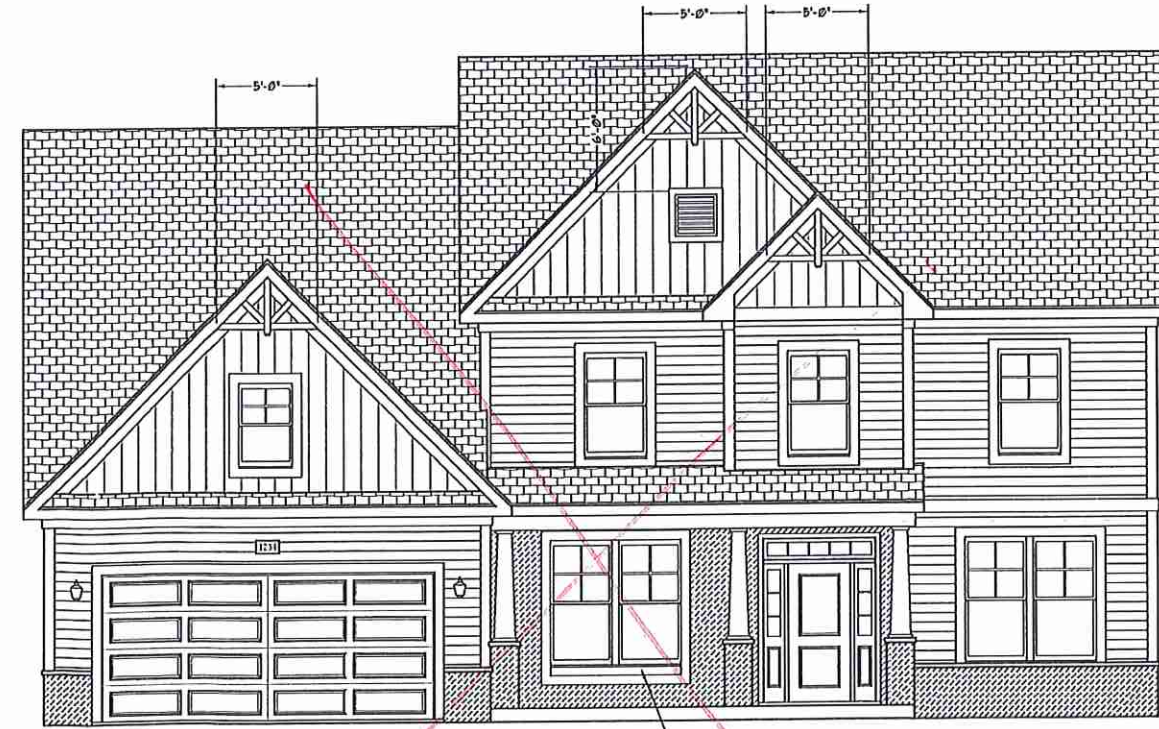


FRONT ELEVATION-B-1

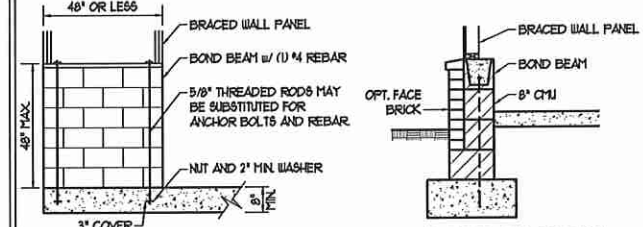

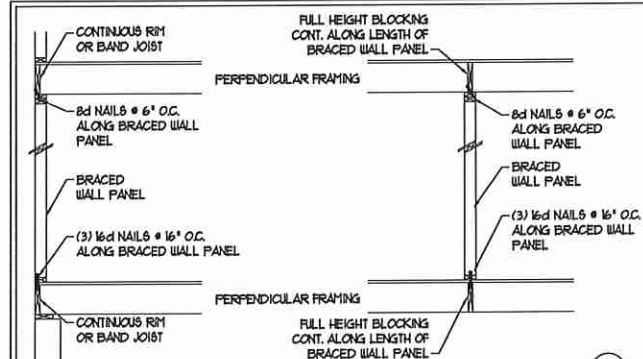

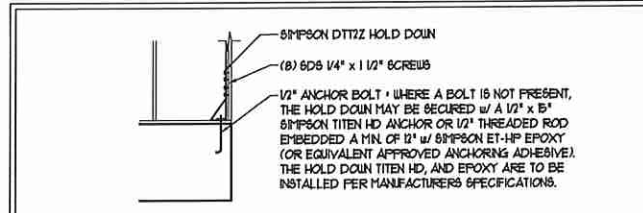

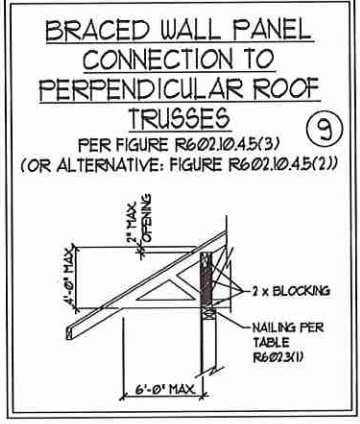
