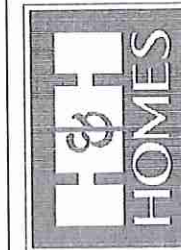


REAR ELEVATION

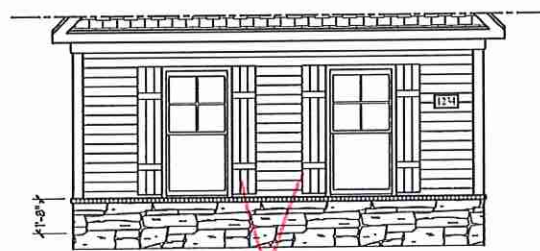

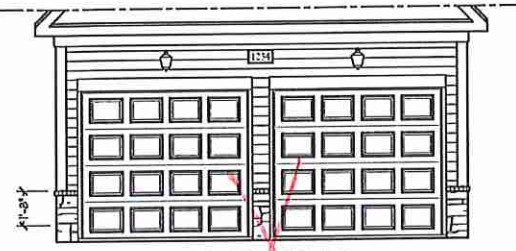

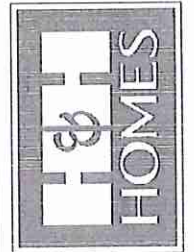


FRONT ELEVATION-B-3 (W/ STONE)

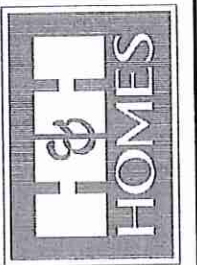


FLOOR PLAN A-4

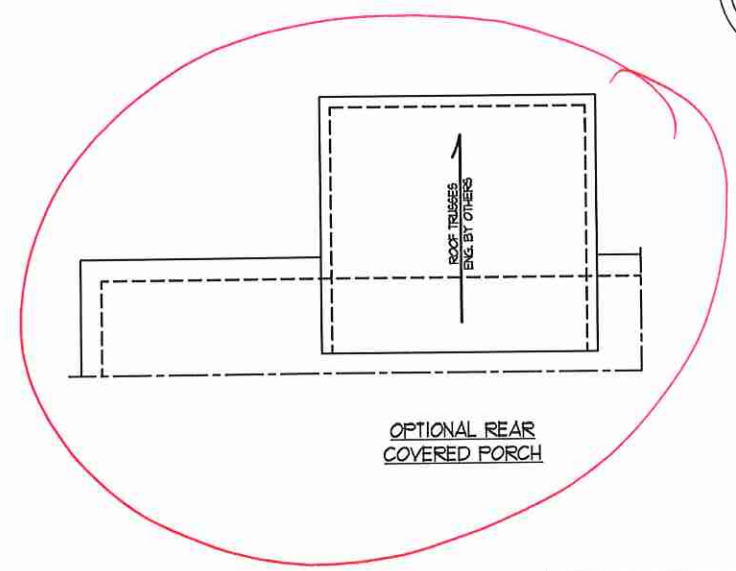

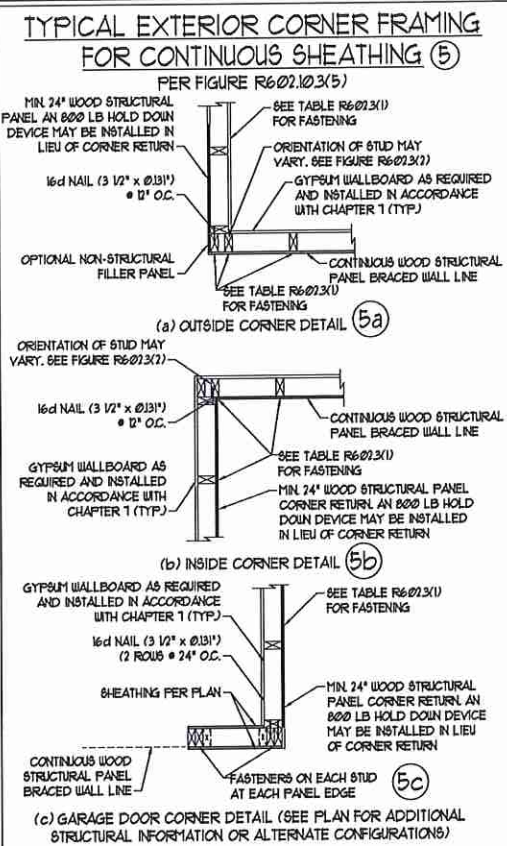

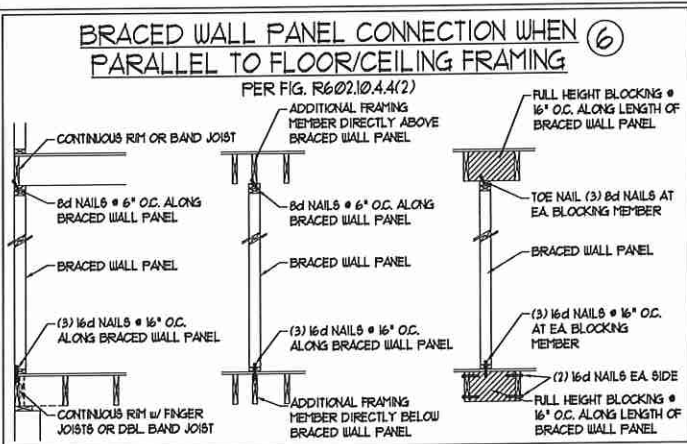

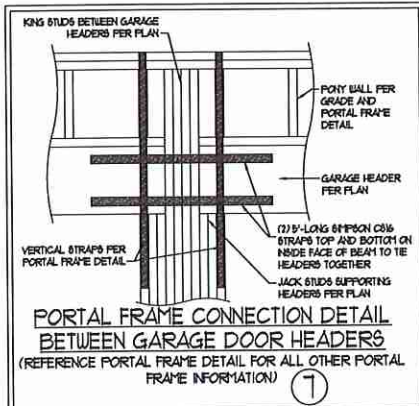

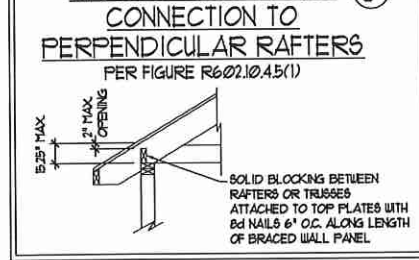

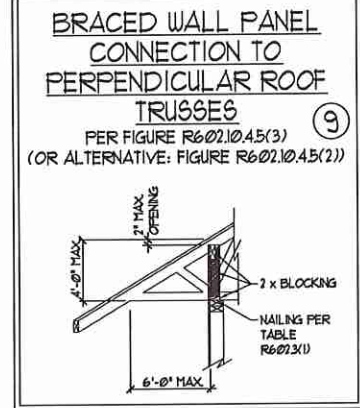
