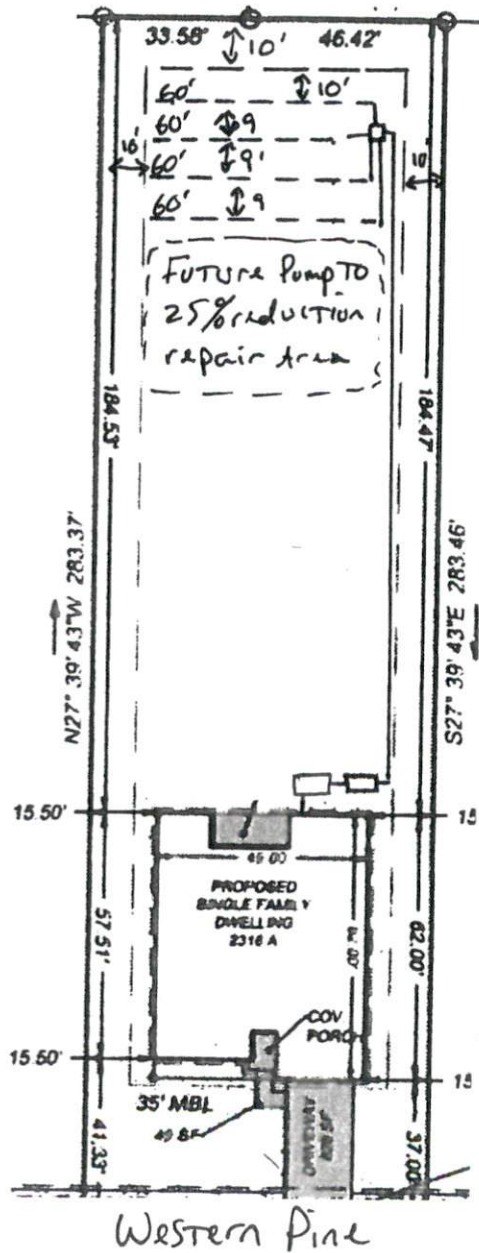

- * Run supply line TO D-Box TO slow flow OF EFFluent TO Drain line
- * Keep Septic Tank + Pump Tank \geq 5' From House + \geq 10' From Property line
- * Clear area for Drain field of Any Plant Growth
