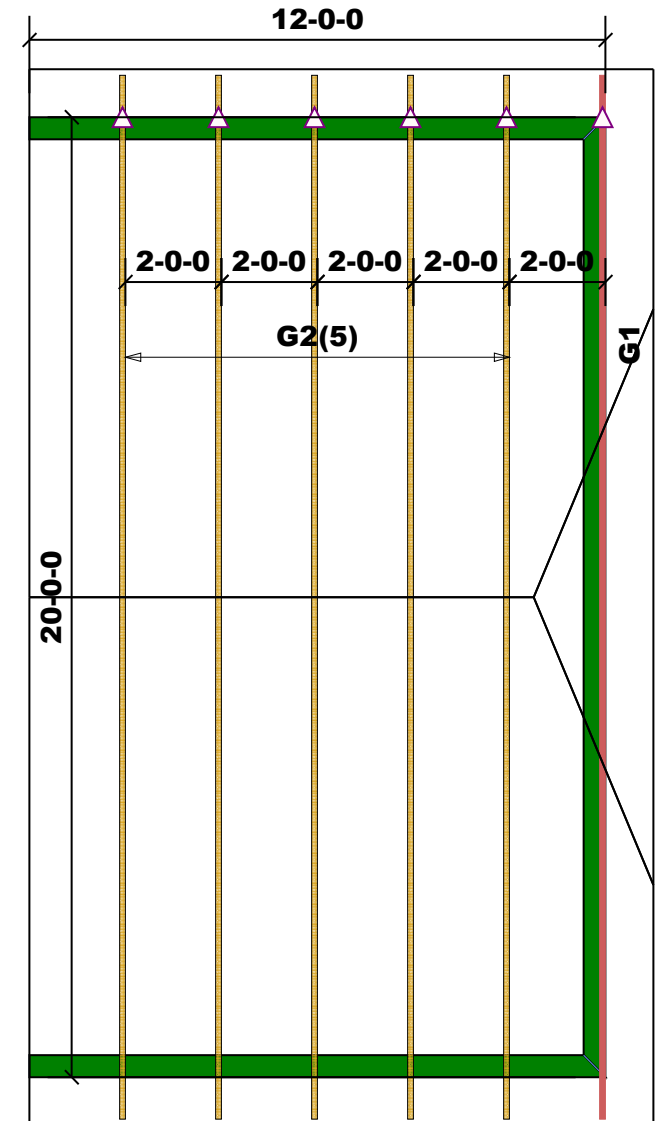
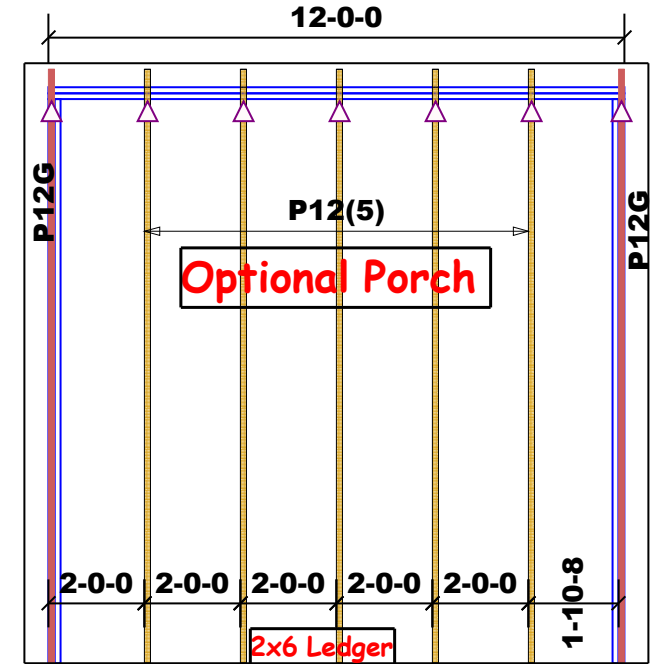
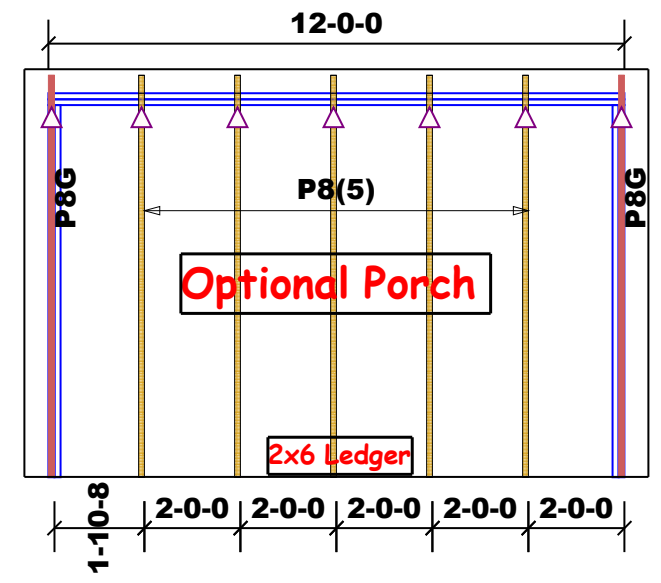
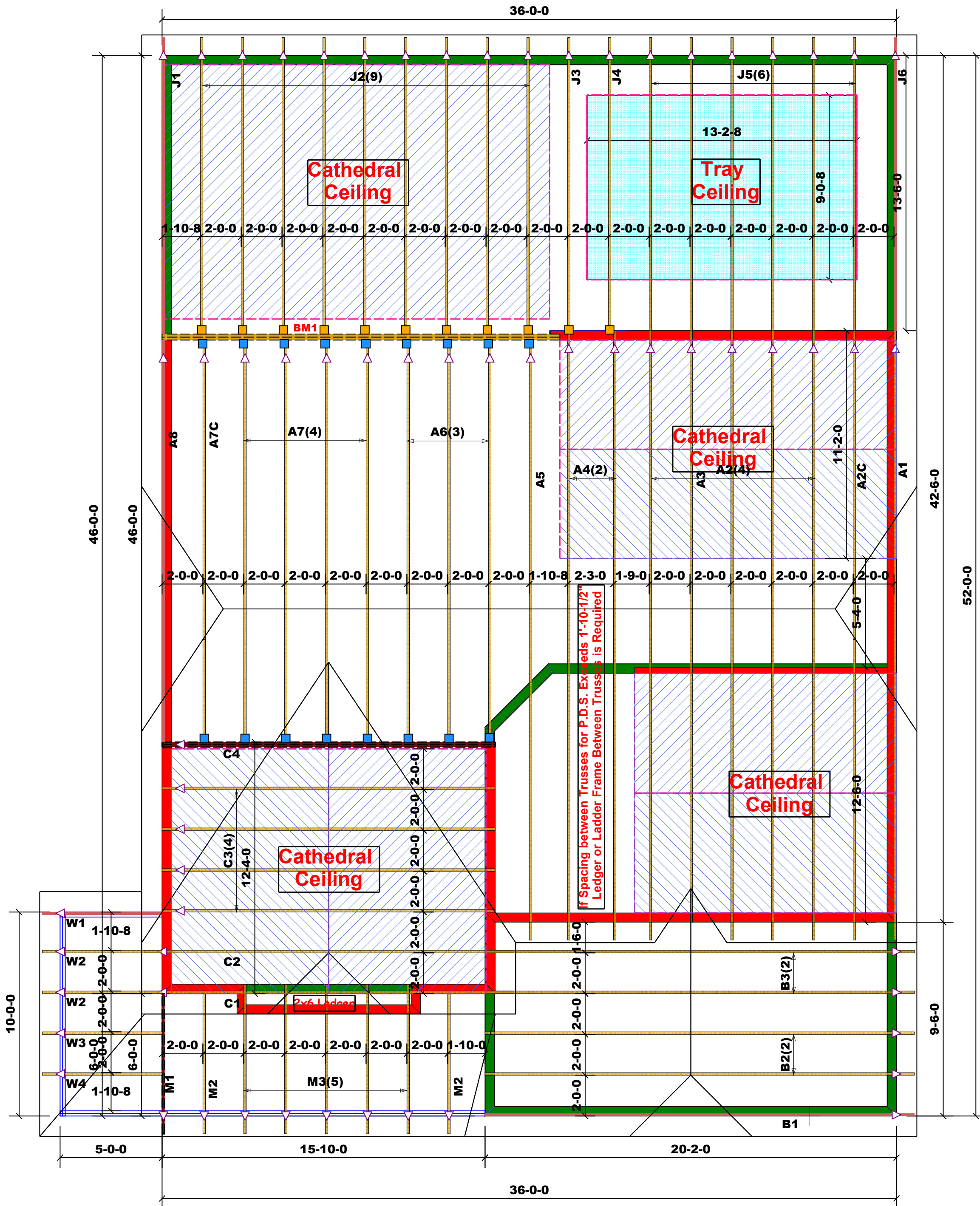

A registered design professional shall be retained to design the support system for any reaction that exceeds those specified in the attached Tables.
