






ATTACH 1/2" PLYWOOD OR OSB GUSSET (15/32" RATED SHEATHING 32/16 EXP 1) TO EACH FACE OF TRUSS WITH (0.131" X 2.5" MIN.) 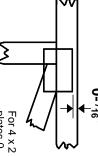

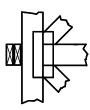

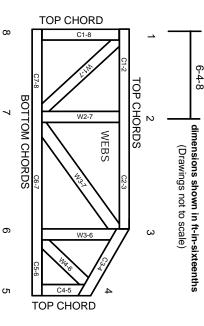
