1/tighten wing wall bolt nuts 2/ Note: tempered glass required at main tub location. 3/ seal floor around drain main bath tub. 4/ fire caulk wire hole top plate above main bath shower valve. 5/repair holes in main bedroom air barrier. 6/ framing of garage window under steel beam doesn't match plan.7/LVL in foyer missing per plan. 8/ ridge beam and valleys mechanical connections missing overhead roof in front foyer.9/ small bath tub shower flange not connected per mfg. 10/ double front window above door missing required number of king studs. 11/ 8x8 column at load point in foyer per plan missing.12/ missing lvl and framed wall for roof gable above dinning room / kitchen location. 13/ could not locate LVL ridge beam and required hanger for beam crossing from bonus room across stairs toward kitchen.14/ seal front porch flashing.
