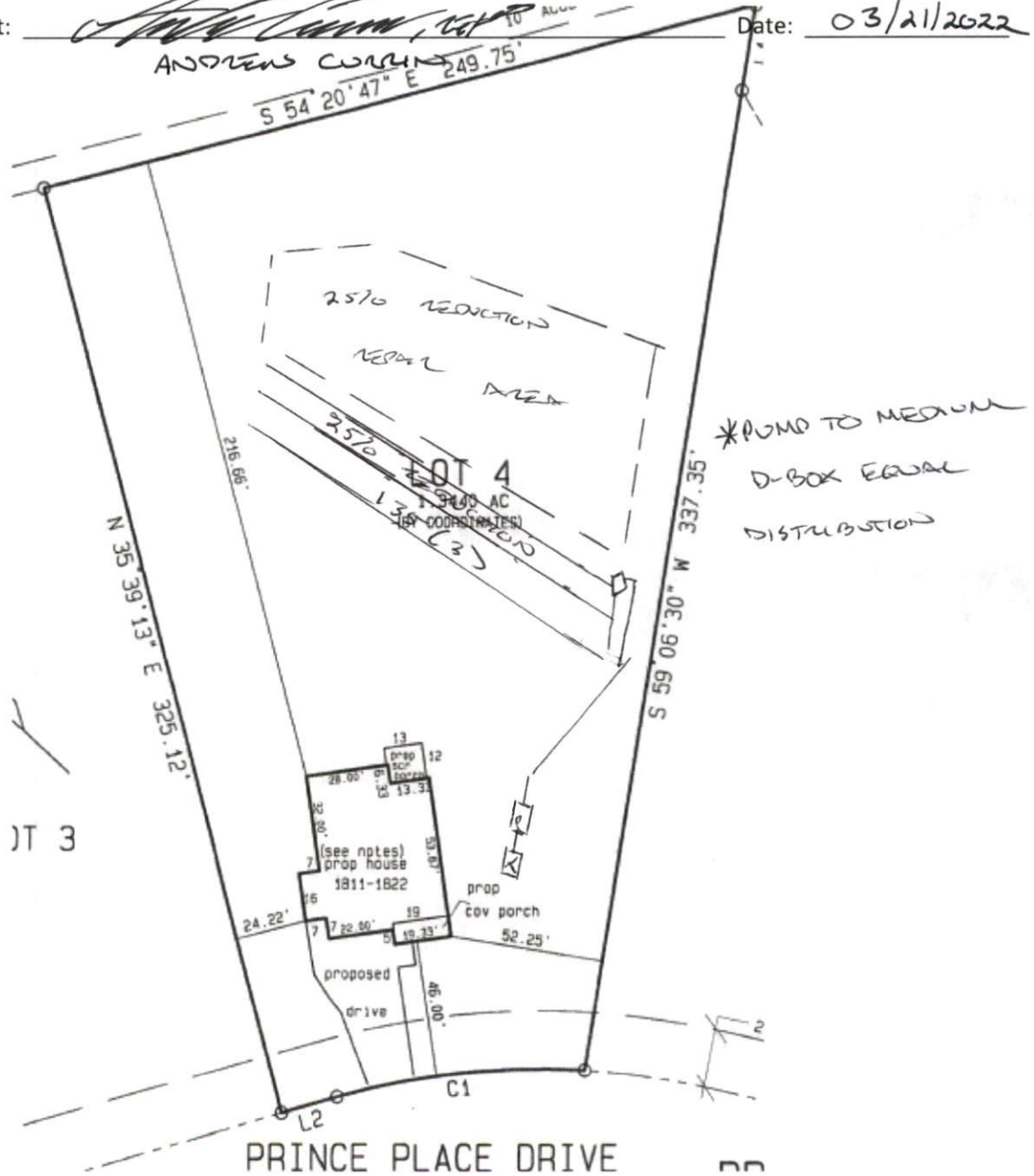

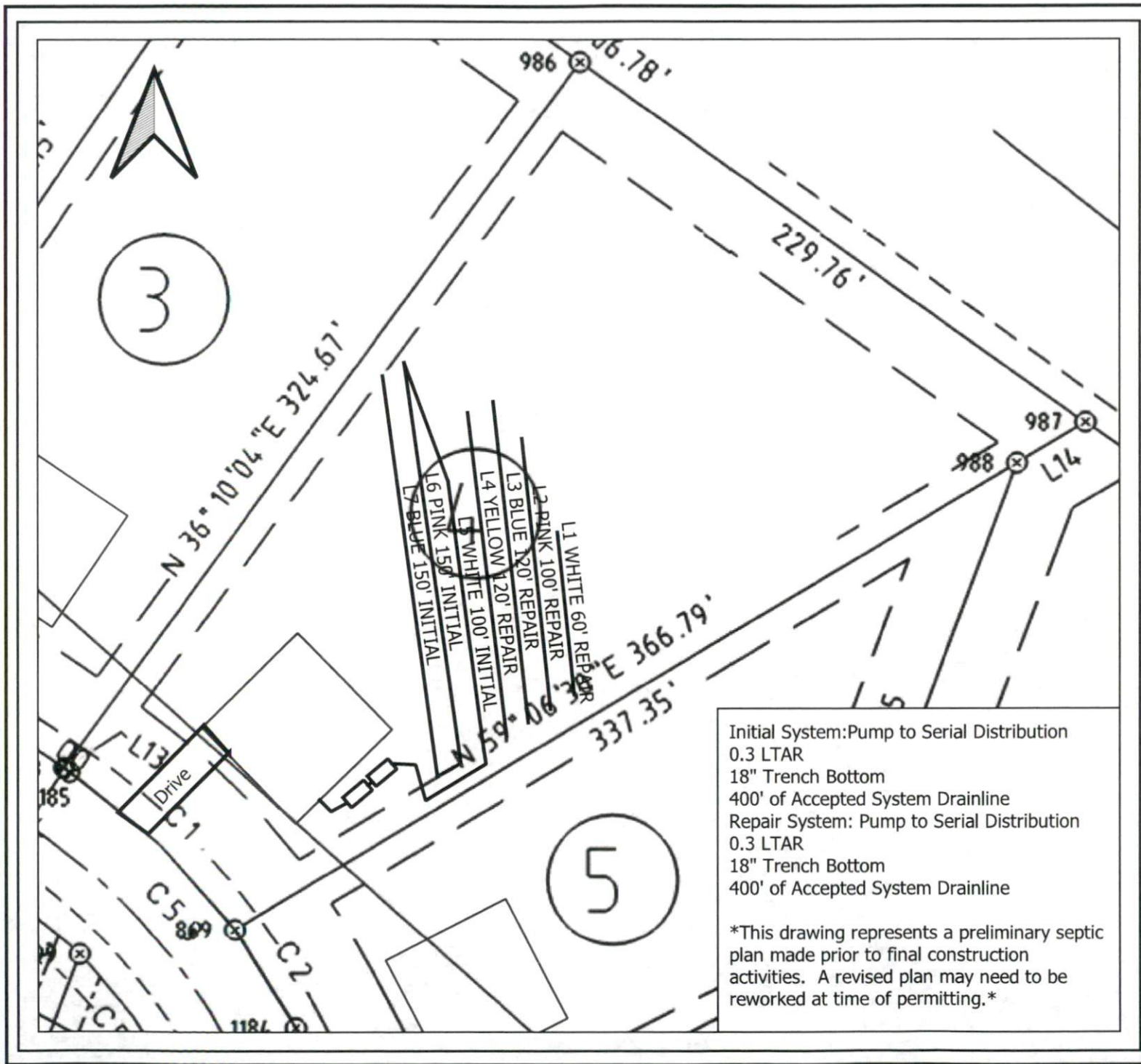
Lot 4
