## Gentlemen:

GeoTechnologies, Inc. has completed the authorized foundation inspection for the residential structure under construction on Lot 28 at Prince Place in Harnett County, North Carolina. Our evaluation of the exposed soils consisted of probing the soils with a 1/2-inch diameter steel probe rod, and performing hand auger borings. The footings were excavated to bear at 0 to 1 foot below plan grade, and then the trenches were set to grade with additional concrete. The results of our evaluation indicate that the exposed subgrades within the footings will provide the 2,000 psf bearing capacity required for the proposed construction. As requested, GeoTechnologies observed that the excavation was per the approved plan, to include the footing dimensions, reinforcement, concrete depth, and frost line depth.


