

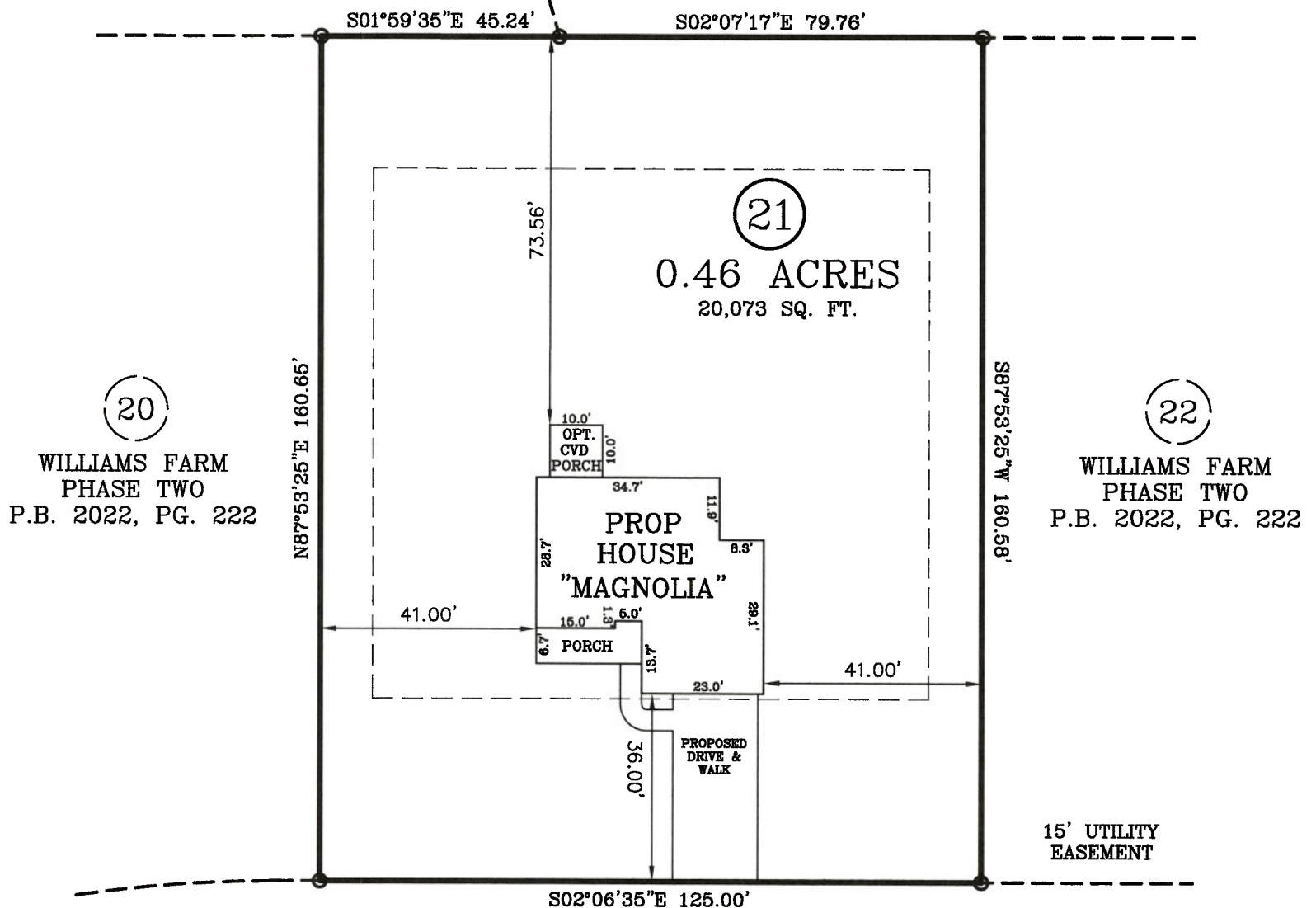
VICINITY MAP

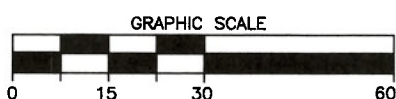

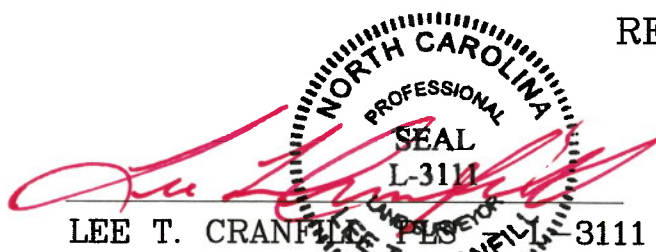
