

- 11) Graphical purlin representation does not depict the size or the orientation of the purlin along the top and/or bottom chord.





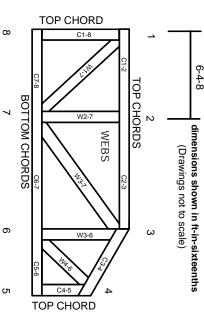
