
The undersigned arrived on site, as requested, to check the bearing for soils at Lot 114. Please see the attached sketch for details.

The footings were not excavated at the time of our site visit. The house corners were staked by others.

To evaluate the bearing grade soils, hand auger borings were performed to approximately 18 inches below the existing pad grade (approximate bearing grade elevation) and Dynamic Cone Penetrometer (DCP) testing was performed per ASTM STP-399 at 12 inch intervals to depths noted on the attached report.

A total of four hand auger borings with DCP tests were performed at four corners of the house. The test results indicated the presence of suitable soils at the areas and elevations tested that will support a foundation designed for a net allowable bearing pressure of 2,000 pounds per square foot.
