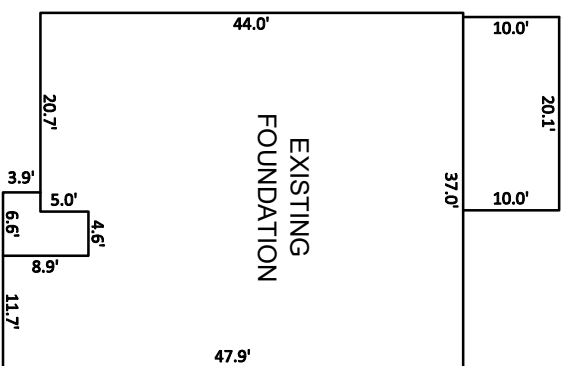

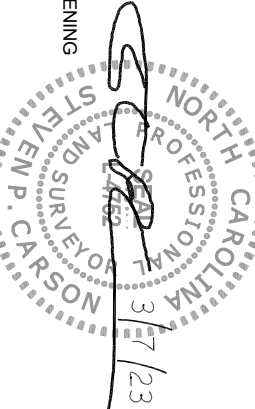
VICINITY MAP
