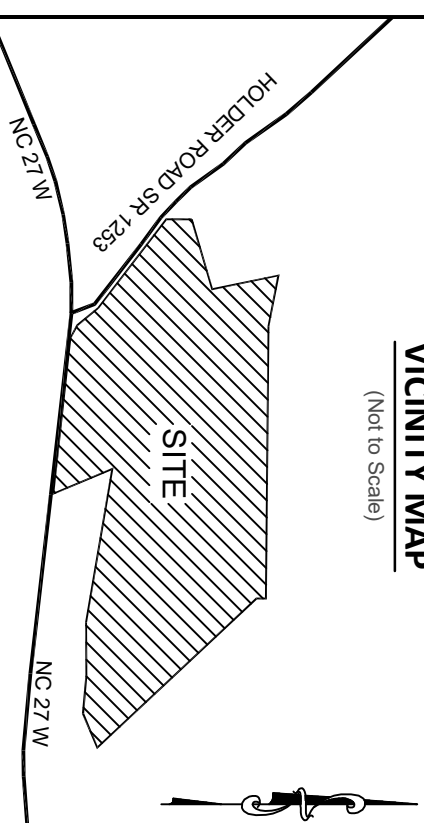

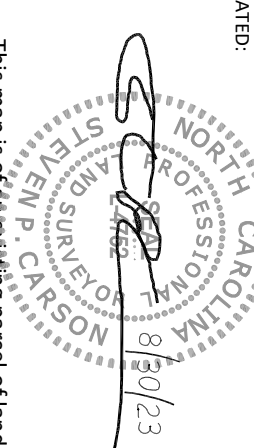
VICINITY MAP
