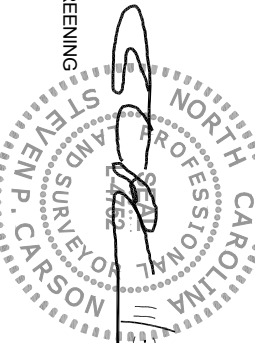
**VICINITY MAP**
