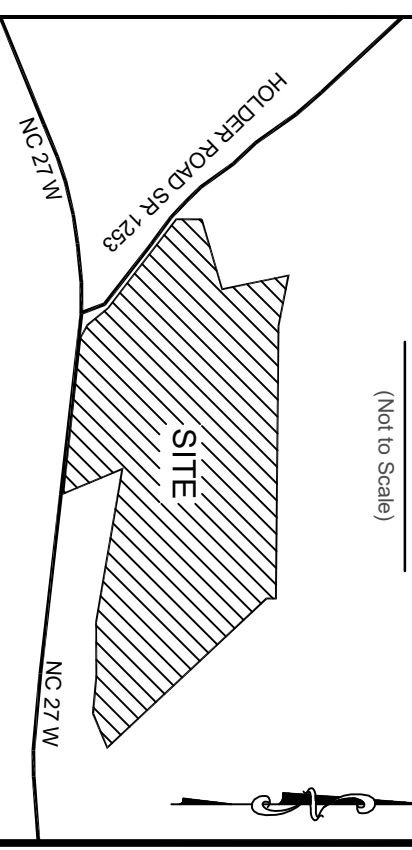


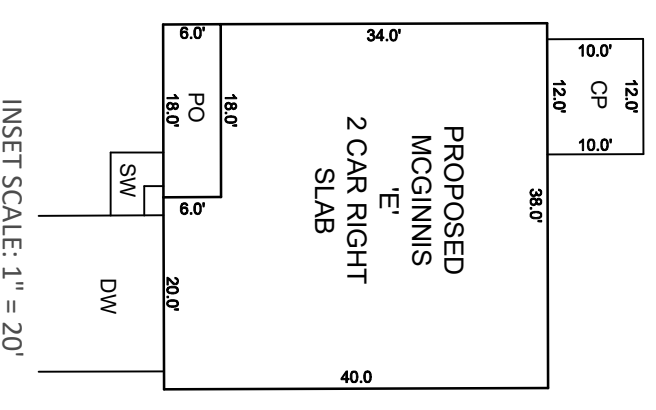

 (Not to Scale)



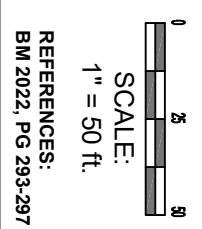
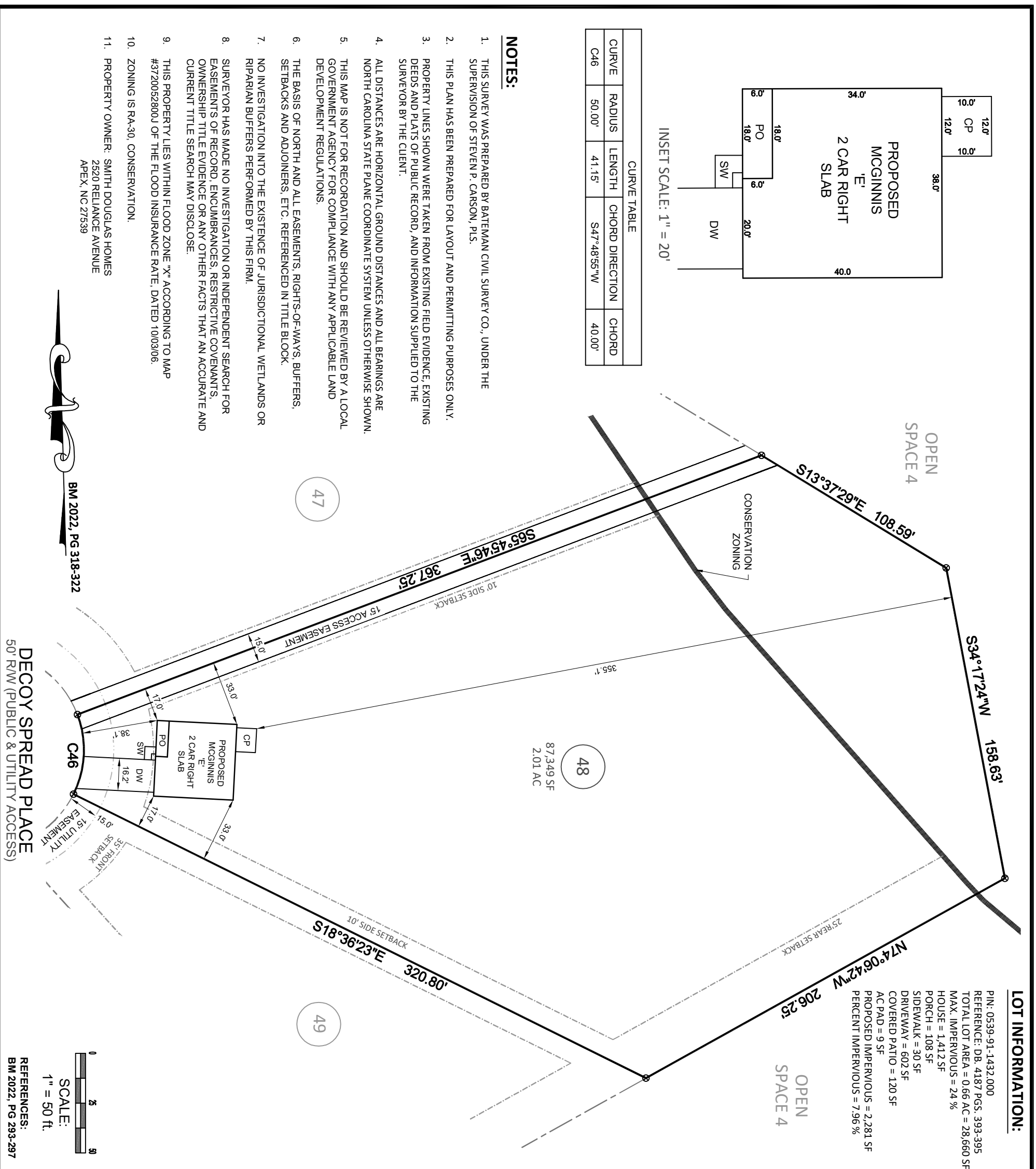
