

Good morning Cassandra,

I cannot see that there is 3 lvls. Looking at the right end of the beam it appears that there is a Lvl block that is wider than a lvl placed between the outside lvls similar to how beams are packed out. If there is a second full length lvl behind the block then it is shorter and I will have to look to see if the jacks are large enough under it to be able to have the correct bearing. A 2x8 was nailed to the top and bottom of the beam making it impossible to see the plies from under or above it also. Do you have a superintendent or anyone over seeing the project that could meet me out there at the next inspection so that we can resolve this and move along? I am normally out that way first thing in the mornings. I have attached a photo to show what I am describing. Thanks
