Footings measured minimum 20" wide and 8" deep. Probed footings and pier footings and found them capable of supporting an allowable soil bearing capacity of 2000 psf. Spacing and dimensions of pier footings was in accordance with architectural foundation plans on-site. Contractor has placed #5 rebar 12" O.C.E.W. in 2 - 32" X 32" spot pier footings as according to plans on site. Footings were free of loose soil and cleared of any organics. This work was performed in accordance with accepted engineering practices as required by the 2018 North Carolina Residential Building Code. This area was approved for the placement of 3000 psi concrete.
