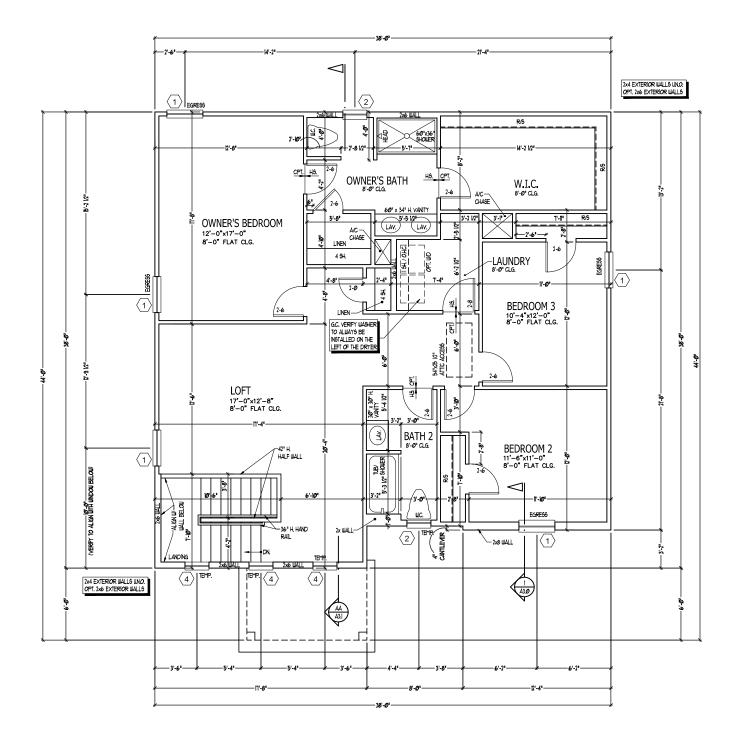

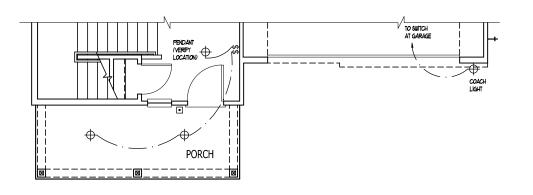








PARTIAL FIRST FLOOR PLAN-B
