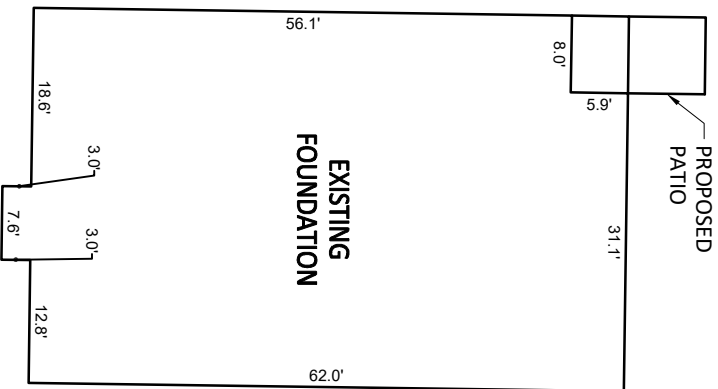

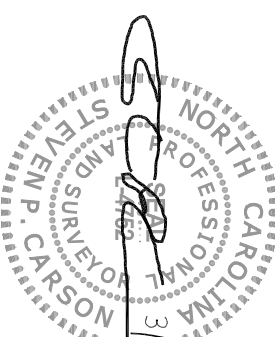
VICINITY MAP
