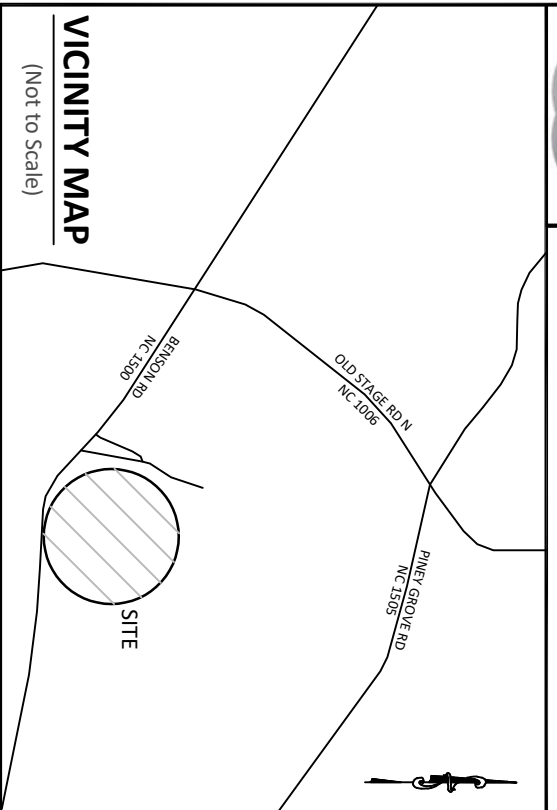

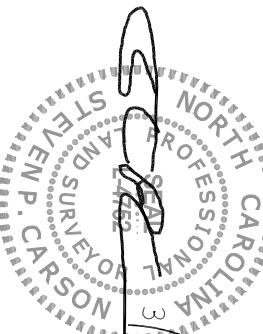
VICINITY MAP

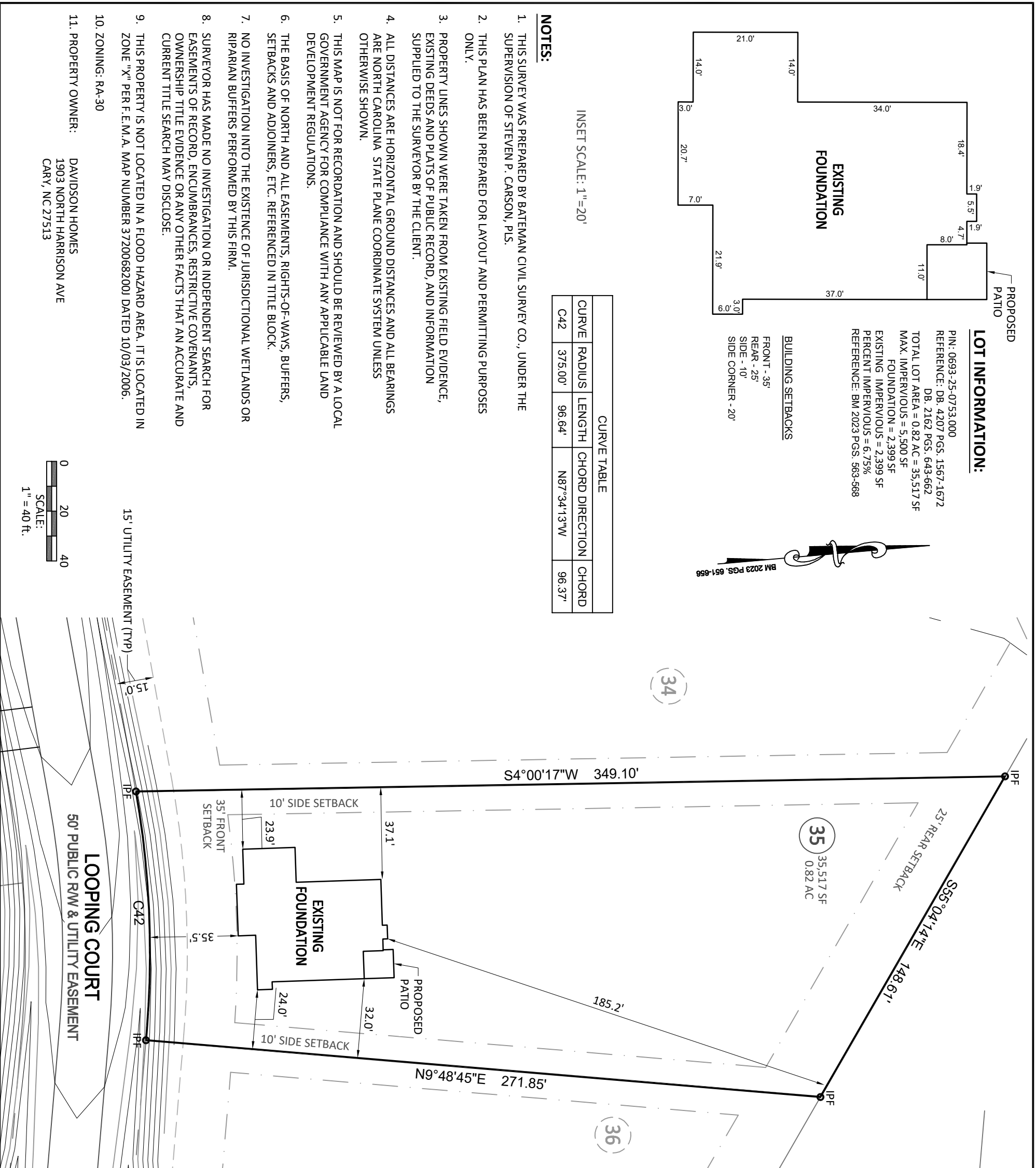
