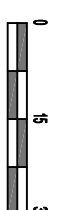

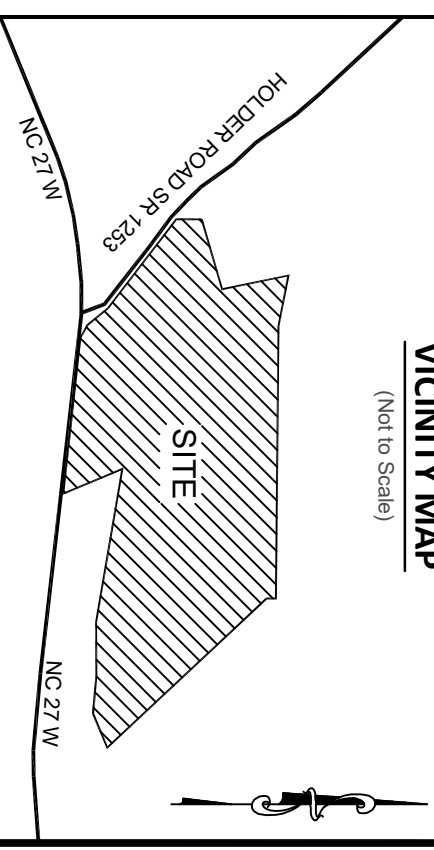

VICINITY MAP

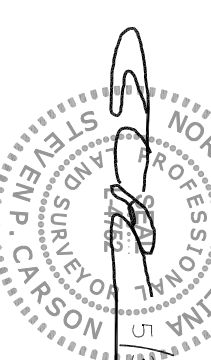
