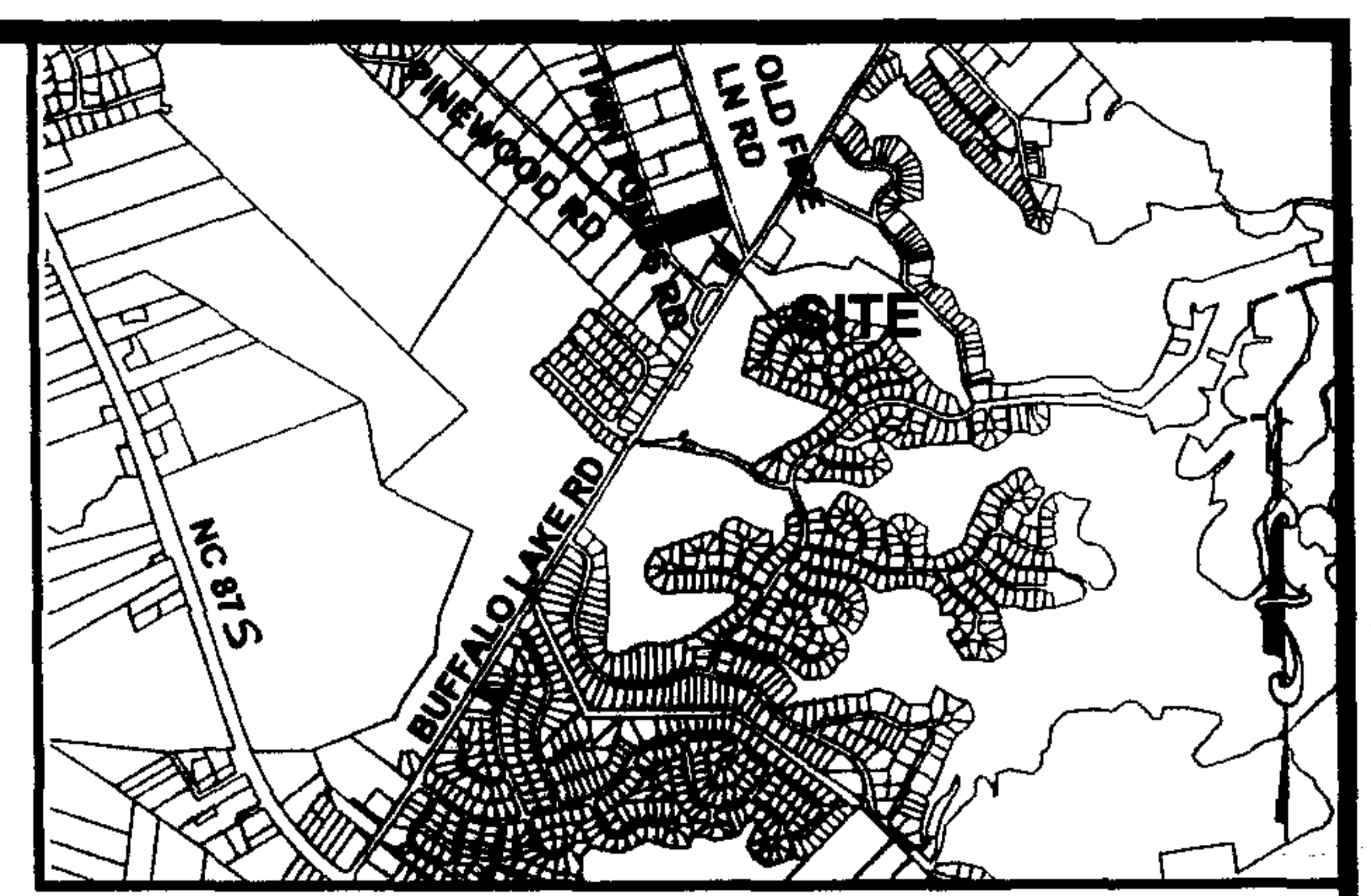

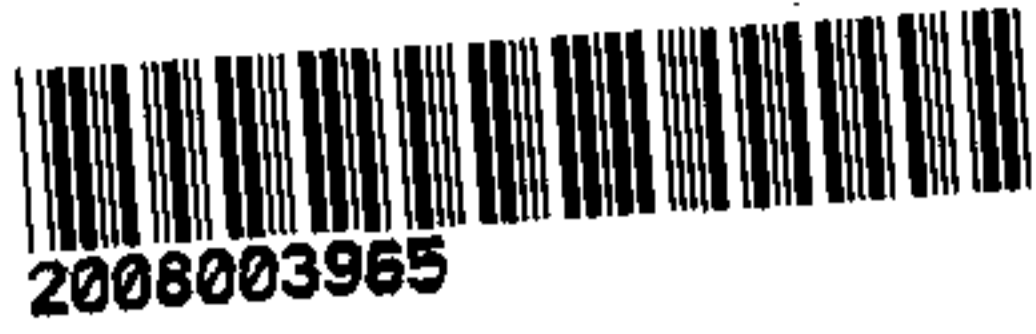

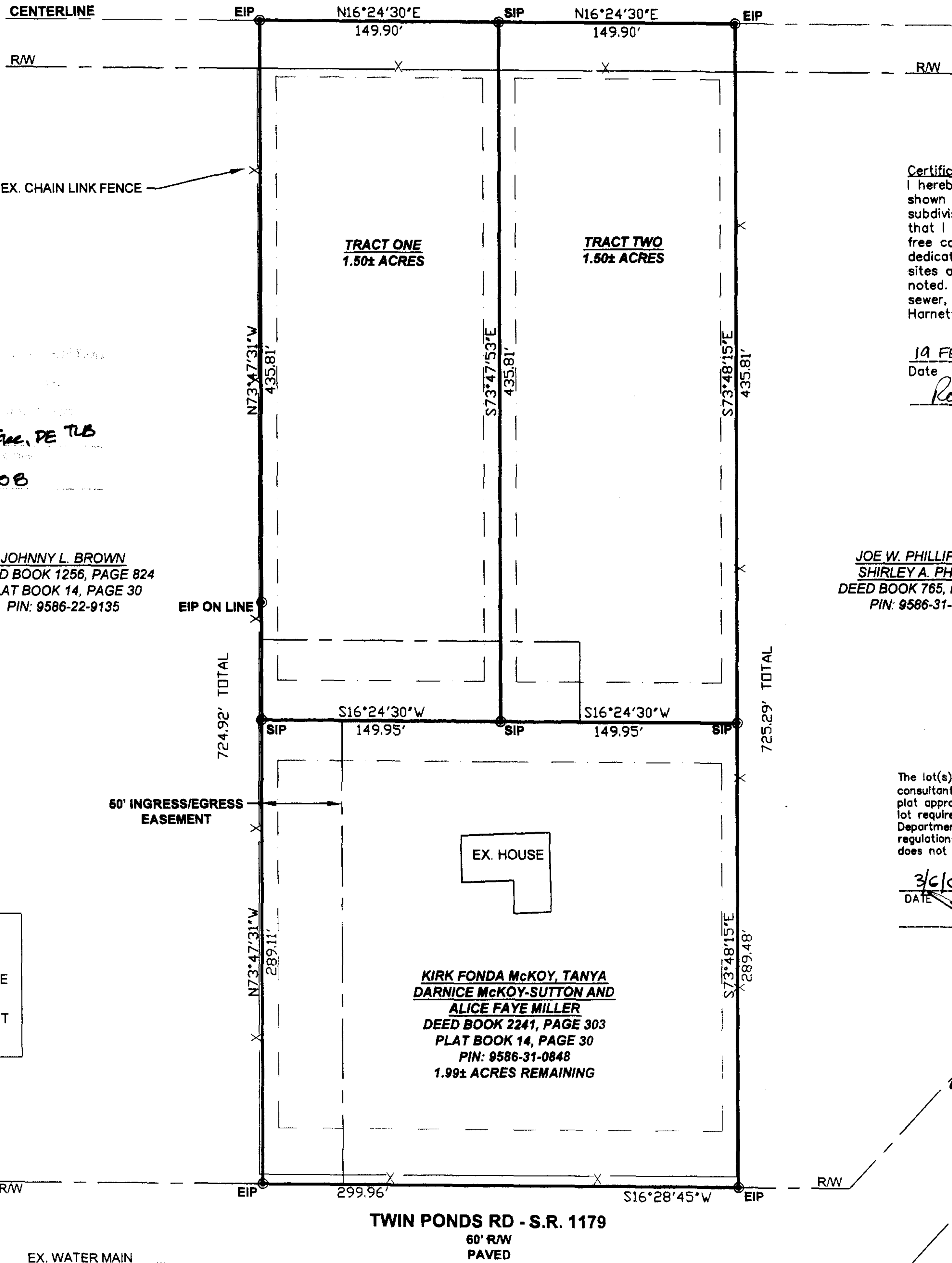


**VICINITY MAP**

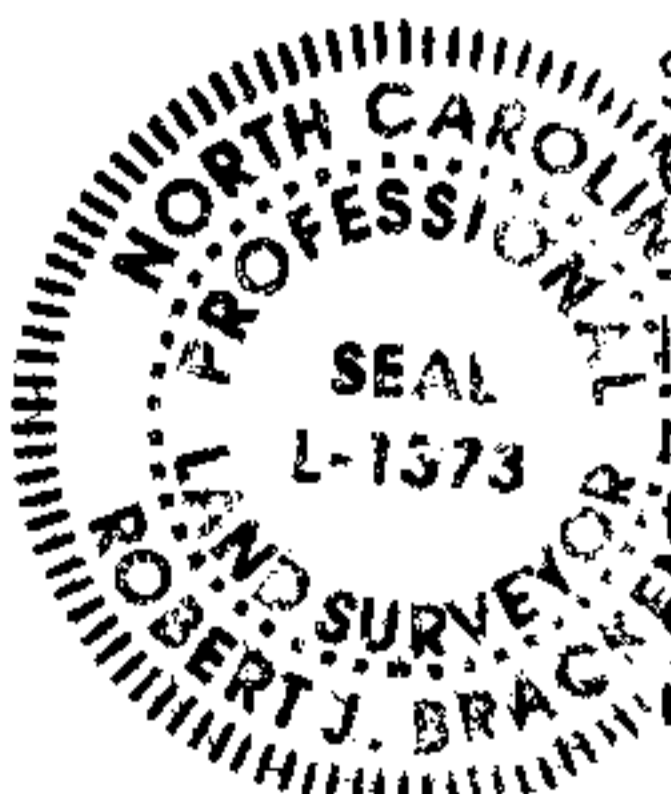

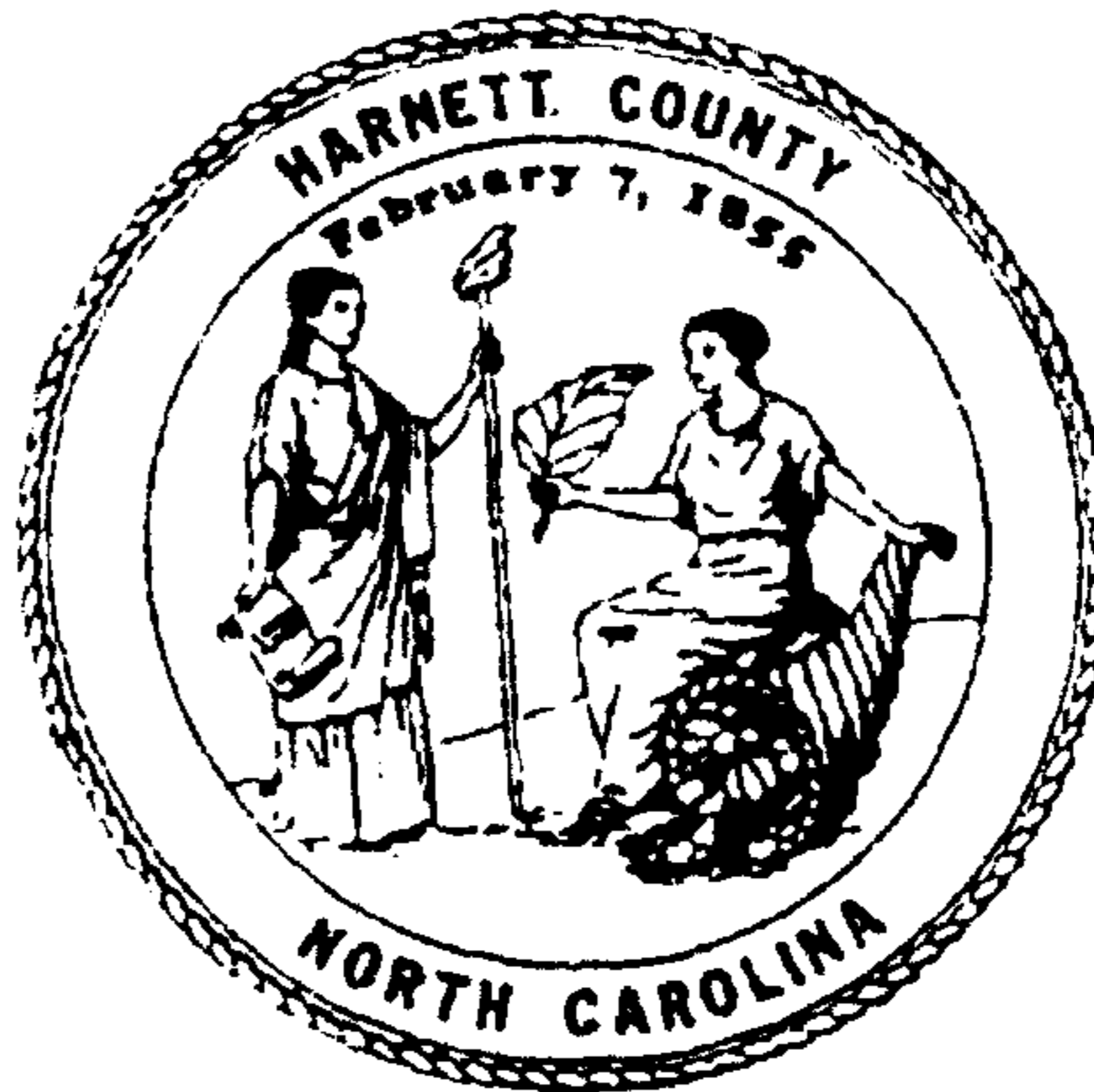
