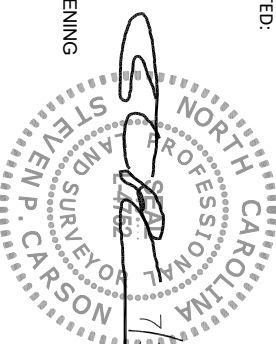


VICINITY MAP
