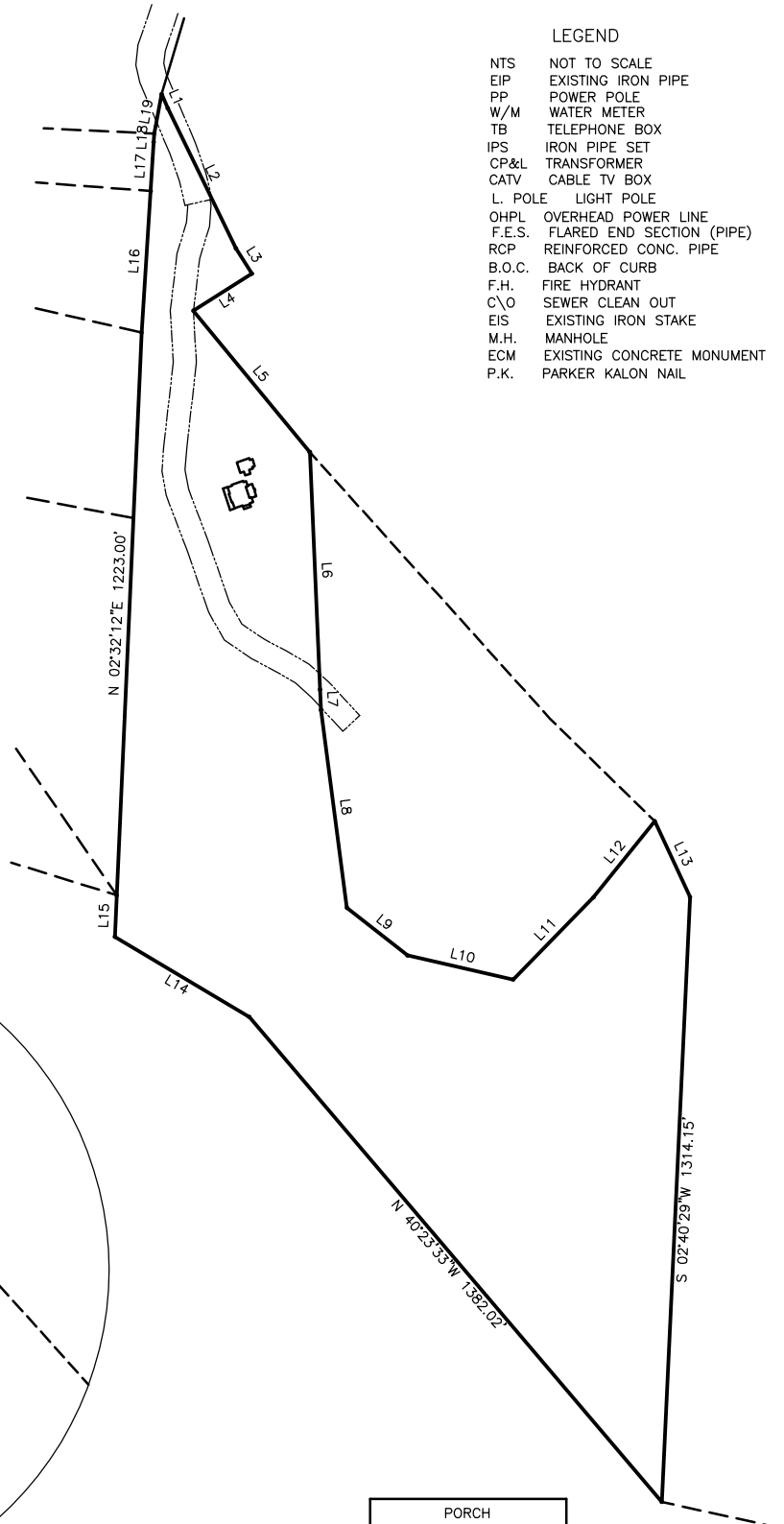


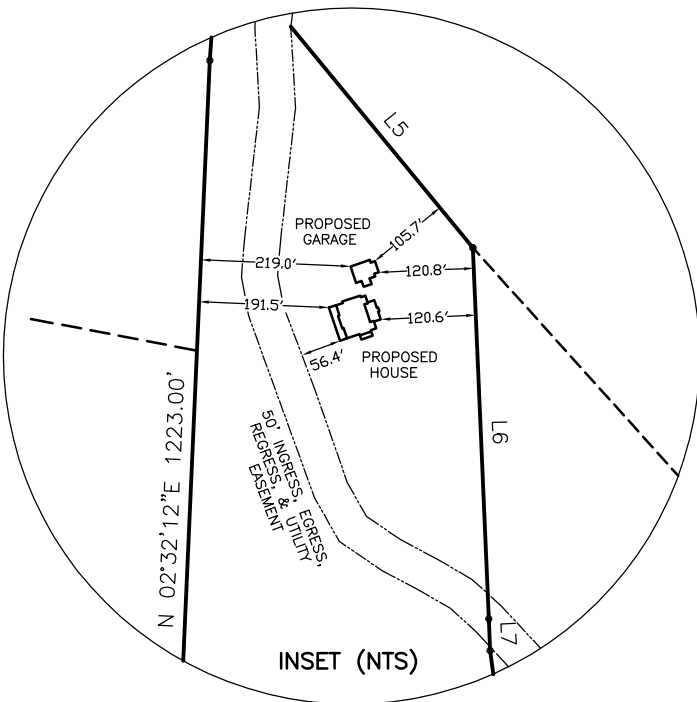

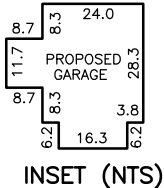
PLAT NORTH

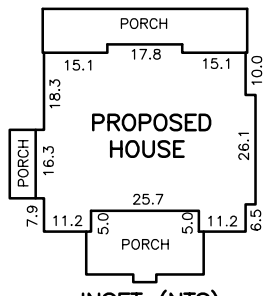

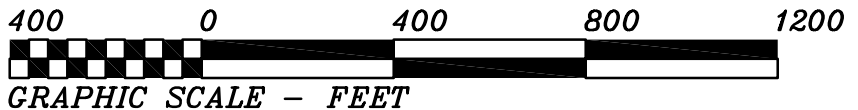
